Purpose of UAFE / ICAFE:

Mission call:

We all observe the need of our young nationals from all parts & region to assist their society to a much better development we surely can utilise necessary comprehensive mechanism at hand with international system to better get these young folks the ability to face great challenges for their countries & area.

Under its deep commitment to a sustainable future, the Intergovernmental Collaborative Action Fund for Excellence aspires to regenerate the Glory of the Planet Earth, in its integrity & abundance, to assure respectful place to all creatures in their intrinsicalities & attributes, and open ways for licit progress through intergovernmental union and sustained educational progress & realm.

Efforts:

Presently, the Earth's physico-structural and eco-environmental systems are acutely under strain owing particularly commercio-industrial malpractices and militrio-strategic priorities, bringing havoc to natural cycles of the planet. Carbon-based economy and consumption patterns among others have unleashed the perils of global warming and climate change, which have in turn induced ranges of calamities (e.g., drought, desertification, deforestation, glacio-iceberg melting, rising seas, reducing surface waters, rain-reduction, cyclones, hurricanes, tsunamis, floods, earthquakes), still producing disastrous impacts (e.g., agricultural ruinage, food reduction, livestock reduction, marine-stock reduction). Result is a widespread habitat loss, property damage, bio-botanic decay, malnutrition, hunger, disease, pestilence, poverty, tension, and war, with spiraling gloomy consequences. These are yet accentuated by burgeoning pollution of lithosphere, hydrosphere, atmosphere, and even the outer space is affected. Ruthless exploitation of the Earth's living and non-living resources, in oblivion of the planet's regenerative capacities and sustaining processes, have critically damaged

the renewable planetary system almost beyond the threshold of reversibility. In the face of exploding human population with constantly increasing needs, and rapidly shrinking resources with irreversible trends, the integrity and interdependence of terrestrial elements has been lost, detrimentally disturbing the fragile life-supporting system. Thus, not only the planet and its constituents have become sick, but also the animal existence has been brought to a brink of extinction. Human society and civilization are in particular at the path of suffocation, with serious implications (socio-cultural, financio-economic, politico-administrative, etc.)

Modalities:

The modalities to deal with such challenges, as buttressed by appropriate policies and strategies, may inter-alia include: i) formulation of integrated and comprehensive plan of action; ii) strict prohibition of terrestrial destabilizing usages and activities; iii) mandatory regimes of preservation, conservation, and protection of all resources; iv) rationalization of exploration, development, exploitation, distribution, and use of resources; v) invigorating safeguards against vulnerable regions and species; vi) introduction of cleaner technological and developmental practices; vii) interjacence of emission reduction and climate proofing; viii) proper usage and consumption proclivities of resources; ix) rationalization of industrial complexes and commercial regimes; xi) depreciation of fossil fuels and appreciation of renewable energy grits; and xii) recognition of human priority in all facets of life and progress with respect to sustained developmental goals and peaceful coexistence.

Goals:

In the light of the above, the sensible goals must at least be to: i) arrest the destructive course and reverse its advancement; ii) restitute and compensate the damages done; iii) adopt a constructive course for a viable life and sustainable future; and iv) ensure survival and advancement of mankind with respect to its government & society.

Purpose:

Accordingly, the purpose of the Intergovernmental Collaborative Action Fund for Excellence is to encourage and support (morally, intellectually, financially, and otherwise) those organizations and institutions, which are seriously and proficiently engaged in subscribing to the above-mentioned policies and bringing about the above-mentioned goals, particularly aligning with the efforts of the international community and the United Nations. These shall basically and generally include the following fields of endeavors: i) preservation, conservation, and protection of eco-environmental systems; ii) preservation, conservation, and protection of terrestrial resources; iii) bringing about a integrated & sustainable development systems; iv) respecting interdependence of living and non-living resources; v) ensuring human survivability and progress. Specially and specifically, they will embrace such areas of human endeavors as: i) social & cultural enhancement; ii) nutrition and food insurance; iii) peace & security provision; iv) education and training facilities; v) health & medical amenities; vi) human rights & humanitarian advancement; vii) population trends & adjustments; and viii) other intimately related realms such as emerging developing countries about membership to ICAFE.

Functions:

Functionally, depending on the prevailing circumstance, the Foundation will periodically determine areas of priority to be pursued its goals & human endeavor.

Selection Procedure:

The recruitment of beneficiary organizations and institutions shall be based on: i) conceptual criteria, declared purposes, and policy aspects; ii) regimes of competence, levels of growth, and records of performance; iii) levels of proficiency, accomplishment, and reputation; and iv) scope of general recognition, associational ties, and cooperative intent with government and social structure in general for peaceful world.

Organization:

The structure of the Foundation shall consist of the following: Executive Board of Trustees: Comprised of five to seven members, Board of Trustees shall be the supreme governing body of the Foundations & organisation. Working on a renewable term of five years on a plurality voting system, with a casting vote of the Chairperson, who is periodically elected by participating members with a quorum of four to six respectively. The Board shall also formulate its own Rules of Procedure as needed.

Cooperation: The Funds from work shall be amenable to cultivate cooperative, collaborative, coordinative, & working relationships with conducive organizations & institutions, particularly associated with the international community such as diplomatic member states of its treaty and / or the United Nations system.

Location:

Budget:
