

8/6/2018

Deputy Poling assisted New Martinsville Police with a search for a person that was wanted on an outstanding warrant for armed robbery and assault. The person fled on foot, K-9 Neron was able to pick up a track however it ended at State Route 2.

Deputy Blamble handled a walk-in complaint in reference a female juvenile getting text messages from an adult male. The messages were viewed with consent of the mother and nothing incriminating was discovered within the messages. The mother was advised to have the number blocked from contacting her daughter's phone.

Sgt. Warner responded to a crash without injury on State Route 26 North of the airport. The vehicle was still drivable and there was minimal damage to the property where the incident occurred. The driver was cited for failure to maintain control and information and photos were gathered to complete a crash report.

Deputy Barton responded to a complaint of people driving too fast on Pleasant Ridge Road. Contact was made with the caller and she was advised that we would get more patrols in that area.

Sgt. Warner and Deputy Barton responded to the call of Domestic Violence at a residence on Belmont Avenue in Beallsville. After further investigation, it was determined that the alleged incident had taken place in Guernsey County. Guernsey County Sheriff's Office was contacted and informed of the allegations and the male was advised to contact GCSO.

Contact was made with a neighbor who advised that the subjects were on vacation and would be gone for about a week. Attempts were made to contact the father, but were unsuccessful.

Deputy Weekley witnessed a vehicle drive down onto the laydown yard property after working hours he made contact with the vehicle. The driver Justin Marte was found to have a suspended drivers' license and was cited. He advised that his boss owned the property and he was showing his girlfriend and kids where he had been working.
