From The Board:

2015 Pool Schedule Changes

As this very cold winter comes to an end, the Board would like to present the Swimming Pool Hours for the 2015 season. Last pool season, we attempted to accommodate early morning swimmers by scheduling morning swim hours on some days. After analyzing the pool usage data supplied by our pool company, the Board determined that the primary hours the pools are used are 2:00 pm – 8:00 pm. Last season, there were over 200 hours at each pool that we staffed where there were no swimmers at all,



mostly in the morning. Therefore, the Board has modified this season's pool hours to be in line with last season's actual usage. These revised hours will reduce this season's pool operating costs by almost \$9,000. Please see page 2 for the 2015 pool schedule. There is a City of Sugar Land pool located on Wood Street that Sugar Mill residents may use if they want to swim outside of our hours. The City pool is open 7am-10pm.

Marion's Fishing Corner

Wintertime fishing in Texas is certainly a "hit or miss" proposition. So much of your fishing success is directly affected by the weather, and we all know how unpredictable our weather can be. That being said, here are a few things to consider while planning a fishing trip this month.

During the cold months of the year, you will usually have better success fishing clear to moderately stained water instead of murky or muddy, especially once the water temperature dips into the mid-50-degree range. Most fishermen consider cold, muddy water to be the absolute toughest of all fishing conditions. In addition, the deeper and clearer a lake is, the longer it takes for the water to cool during the winter. You can usually find warmer water and more active fish in a clearwater environment than you can in a shallow, murky one.

Because bass are cold-blooded creatures, their metabolism slows as the water temperature drops in winter. They tend to move shorter distances and eat less often, targeting smaller prey when they do eat. This perhaps explains why slow-moving, bottom baits such as jigs and soft plastic worms are among the most effective cold water lures.

During winter, bass in lakes with slightly murky water tend to be much shallower than bass living in clear water conditions. Also, they will hold tighter to wood and concrete structures and are less likely to suspend out in open water. Shallow running crankbaits are a good choice for these fish.

Many lakes in our area undergo a "shad kill" in winter if the water temperature remains in the low 50's for an extended length of time. Threadfin shad will go into shock and twitch erratically as they sink slowly to the bottom. This is a major feeding stimulus for gamefish. A slow-sinking soft plastic worm or stickbait in a pearl colored finish can be very effective in this situation.

So keep these few observations in mind on your next fishing trip. Try to have realistic expectations when fishing in winter. Instead of hitting the lake with the anticipation of fast action, be aware that the fish will probably be lethargic and the bite will be slow. But also be aware that your chances of encountering a really big fish are excellent this time of year.

Remember to catch and release, because a bass is far too valuable of a resource to catch just once.






