as follows:

SECTION 1. TITLE

This local law shall be known as Local Law No. 2 for the year 1996 and will reduce the maximum weight of motor vehicles which travel the Old Golf Course Road in the Town of Hampton to eight (8) tons with the exception of local deliveries and setting a minimum fine of one hundred (\$100.00) dollars for those who violate such weight restriction.

SECTION 2. PURPOSE

The purpose of this Local Law is to set the maximum weight of motor vehicles on Golf Course Road at eight (8) tons.

SECTION 3.

It having been brought to the attention of the Town Board of Hampton that evident deterioration of the Golf Course Road has occurred due to the use of the road by heavy tonnage vehicles.

SECTION 4.

Pursuant to the Town of Hampton's Board of Trustees responsibility to protect and act in the best interest of the community and whereas in part those duties are the assurance that the integrity of all public roads will always be maintained and that the present construction of the road is not suitable for heavy tonnage traffic and that further use by the same will cause the road to fail, that from and after the effective date of this Local Law, the maximum tonnage of any vehicles using the Golf Course Road will be no greater than eight (8) ton. The minimum penalty for violation of this Local Law will be one hundred (\$100.00) dollars

SECTION 5.

This Local Law shall take effect immediately upon filing in the office of the Secretary of State.
