## **Running Order and Class Information**

Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at [LKSAGE@aol.com](mailto:LKSAGE@aol.com) or by phone (503) 840-4303 (cell).

**Due to low entry numbers we have made a judge change. Sherry Jefferson will now be judging all classes all three days. If you wish to withdraw your entry because of this judge change, you may do so and receive a full refund for the classes affected. Because of this change we are adjusting the class run order to make for a more efficient running trial.**

**SITE INFO:** This trial will be held in two rings under cover in a partially enclosed arena on packed dirt. You can crate outside on dirt around the periphery of the arena building or you may crate in the Show Stadium building a short distance from the rings. **You may set up your crating space Thursday afternoon beginning at 3 pm.**

### **DIRECTIONS TO THE TRIAL SITE:**

*From the North, on I-5:* Take EXIT 258. Turn south onto Portland Rd NE. Turn left onto Lana Ave. At Silverton Rd., stay straight and cross through the intersection to enter fairgrounds.

*From the South, on I-5:* Take Exit 256 – Market Street. Turn left onto Market Street. Turn right onto 17<sup>th</sup> Street NE. Turn right onto Silverton Rd NE. Turn right at Lana Ave. to enter the fairgrounds.

Once you've entered the fairgrounds, follow the gravel road through the gate into the fenced parking area. Turn right and head West toward the white stall barns. When you get to the stall barns you will see the arena on your left, across the field. RV Parking for electrical hook-ups only is located on the East side of the stall barns along the fences. The FULL Hook-ups are located on the East side of the Race Barns. As you follow the gravel road into the fairgrounds, turn left (instead of right towards the arena). The full hook-ups will be on the right. RV parking is on a first come, first served basis.

### **CLASS SCHEDULE:**

Check in time will begin at 8:00am on Friday, and 7am on Sat and Sun. The first class will start promptly at 9:00am Friday and 8am Saturday and Sunday.

**MEASURING:** All dogs without height cards will have to be measured by the Volunteer Measuring Official before you run. We will have a VMO available at this trial to measure each day near the trial secretary's table. We will be measuring throughout the day so if you're not entered in the first classes it's not necessary for you to arrive at 8am for measuring.

**PRELIMINARY RUNNING ORDER:** The Preliminary Running Order is contingent on move-up entries not yet received.

**ALL FAST CLASSES WILL WALK TOGETHER AND RUN TOGETHER BY JUMP HEIGHT.**

**GENERAL:** ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

**VOLUNTEERS:** We will be using the White Board system for workers. Please check the board and sign up to work when you can. Workers will receive a coupon that can be used for lunch or may be redeemed for raffle tickets to use for the worker raffle.

**CONFLICTS:** We will do our best to accommodate conflicts. If you have a conflict, Standard takes precedence over FAST and JWW. Put a "C" instead of a check mark on both gate sheets so the scribe and gate stewards will know you have a conflict.

**MOVE-UPS:** The deadline for move-ups is Monday, July 22, 2019 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial day.

**FOOD:** There will be food provided for workers. All others, we appreciate all donations. **No Food Vendor will be available.** We're going GREEN! Workers, please bring your own (BYO) sports bottle, drinking glass, coffee cup, travel mug or other drinking container. Purified drinking water will be provided near the score table. The water will be in Igloo containers.

**HOSPITAL:** Salem Hospital is located at 890 Oak Street Southeast, Salem - (503) 561-5200 open 24 hours a day. Directions and maps are available from the trial secretary and will also be posted at the trial site.

**MACH, PACH:** If you think you'll be earning your MACH or PACH at this trial, we ask that you please come and remind someone at the Score Table prior to the run you think you'll earn it on. As we are often preoccupied with trial and scoring duties, we may be distracted and wouldn't want to miss celebrating your Championship with you. So again, please come and remind us or send someone to remind us and we'll be ready with a ribbon.

**B MATCH:** We're having a B Match on Saturday afternoon one half hour following the last class of the day. \$5 per run. Toys are ok but no food in the rings. Get some extra ring time on your dogs! Dogs do not need to be entered in the regular trials. Dogs may be entered multiple times in the same class with a maximum of 4 runs per dog. Each run will be a maximum of 90 seconds.
