D o you have an elevator speech? If you are like me when I was first asked this question, you are thinking to yourself "What is an elevator speech?" Fortunately, the person who asked me that question was teaching an entrepreneur class that I was attending. I learned that business owners should have an elevator speech that tells someone everything you would want them to know about your business in the time it takes to ride an elevator to the floor you are going to. So I think that concept is applicable to paralegals!

Most of us have a hard time talking about our skills because we are conditioned not brag about ourselves. However, we need to be able to articulate our talents and strengths to employers, potential employers, and colleagues. The best place to start is to list the skills that you believe are your strongest and in which you have the most experience. Having experience in targeted areas of the law becomes a great talking point in your elevator speech. Each of us knows our strongest skills, but we never stop to think about them or write them down. Give yourself credit for the things you do well.

After you have a list of skills, add some personal qualities that will be beneficial in your job. If you enjoy meeting new people, that information will boost your elevator speech. It is important to recognize both strengths and weakness in our personalities to find positions that are most suitable and ultimately successful. I like to work independently so I communicate that to my employers and colleagues to provide insight into my work habits. Utilize your personal strengths to effectively promote your skills.

Next, list your accomplishments, such as obtaining certification or advanced certification. Include local and national organizations that you are involved in. Note any programs or classes you have taken that may be valuable to your position. If you have a professional bio, use information that is included in it. Your participation in these opportunities demonstrates your motivation to continue to develop skills and knowledge of the legal or business field. These accomplishments will round out a great elevator speech. Write your elevator speech! Then practice reading the speech until it becomes automatic and flows smoothly. The instructor of the class I attended allotted a time limit of three minutes for this type of recitation. Find a trusted friend or colleague to practice presenting your speech. During a job interview, for example, if an interviewer says "So tell me about yourself", you will be able to present a soliloquy that is natural, well-thought out, and comprehensive. Once the elevator speech is engrained in your mind, it can be adjusted in the moment to correspond to your situation.

There are many times when an elevator speech is important to have in your arsenal, such as when approaching an employer about a raise, making a case for why you should receive an assignment, or asking for a promotion. Review the content occasionally to make sure it is up-to-date and reflects your current position in your career. It is not easy to "toot our own horns" but having an elevator speech prepared is a great way to easily promote yourself when the opportunity presents itself. Go you!


