1ST TIME DUI

If this is your 1st DUI and in the event that the DMV suspends your driving privileges for 4 months after a loss at a DMV hearing, or if you did not have a hearing, you are allowed to obtain a restricted license if you;

1. *Wait 30 days from the start of the suspension*
There is a 30 day mandatory suspension before you can apply for a restricted license. Your restricted license will allow you to drive to work, from work, during work, and to/from dui classes. Many attorneys have successfully argued in court that a homemaker is a profession and that any driving she does in support of her family is in fact work.
2. *Obtain an SR-22 Insurance Policy.*
An SR-22 is a special type of insurance that is required by the DMV for a person who has been charged with a DUI but desires to obtain a restricted license and not sit out the full 4 month suspension. Call Breathe Easy Insurance for the best prices 949-529-5060
3. *Enroll in the AB541 DUI class*
The AB541 DUI class is a 4 month long class that meets once a week for approximately 2 hours. Please be mindful in certain circumstances the court may require a more extensive class.
4. *Go to a DMV field office and apply for a restricted license.*
There will be an administrative fee required by the DMV.

5. *If the DUI was in Los Angeles County.*

Then you will be required to install an ignition interlock device. The approximate cost to install the IID is \$75.00 and the approximate monthly cost is \$70.00. You will be required to keep the IID on your vehicle for 5 months. Call AlcoAlert Interlock at 888-663-9847

2ND TIME DUI

If this is your 2nd DUI and in the event that the DMV suspends your driving privileges for 12 months after a loss at a DMV hearing, or if you did not request a hearing, you are allowed to obtain a restricted license if you;

1. *Wait 90 days from the start of the suspension*

There is a 90 day mandatory suspension before you can apply for a restricted license. Your restricted license will allow you to drive to work, from work, during work, and to/from dui classes. Many attorneys have successfully argued in court that a homemaker is a profession and that any driving she does in support of her family is in fact work.

2. *Obtain an SR-22 Insurance Policy.*

An SR-22 is a special type of insurance that is required by the DMV for a person who has been charged with a DUI but desires to obtain a restricted license and not sit out the full 12 month suspension. Call Breathe Easy Insurance for the best prices 949-529-5060

3. *Enroll in the SB38 DUI class*

The SB38 DUI class is an 18 month long class that meets once a week for approximately 2 hours. Please be mindful in certain circumstances the court may require a more extensive class.

4. *Install an Ignition Interlock Device (IID)*

The approximate cost to install the IID is \$75.00 and the approximate monthly cost is \$70.00. You will be required to keep

the IID on your vehicle for 9 months. Call AlcoAlert Interlock at 888-663-9847

5. *Go to a DMV field office and apply for a restricted license.*
There will be an administrative fee required by the DMV.

3RD TIME DUI

If this is your 3rd DUI and in the event that the DMV suspends your driving privileges for 24 months after a loss at a DMV hearing, or if you did not request a hearing, you are allowed to obtain a restricted license if you;

1. *Wait 180 days from the start of the suspension*
There is a 180 day mandatory suspension before you can apply for a restricted license. Your restricted license will allow you to drive to work, from work, during work, and to/from dui classes. Many attorneys have successfully argued in court that a homemaker is a profession and that any driving she does in support of her family is in fact work.
2. *Obtain an SR-22 Insurance Policy.*
An SR-22 is a special type of insurance that is required by the DMV for a person who has been charged with a DUI but desires to obtain a restricted license and not sit out the full 24 month suspension. Call Breathe Easy Insurance for the best prices 949-529-5060
3. *Enroll in the SB38 DUI class*
