Mayor Burger shared a voicemail from Mr. Gogel concerning a land swap taking place at the Sunset Subdivision. The Council took into consideration the lot sizes and the cost to run utilities to this new area. Mr Gogel was asking for \$15,000.00 with the land swap due to crop rates/forecasts. The potential for growth and moving back towards town were key factors. Feldmann moved, second by Risser to approve the swap in the Sunset Subdivision with Mr.

Gogel along with a sum of \$15,000.00 Ayes: all. Carried.

Feldmann moved, second by Marugg to have the survey of the land in the Sunset Subdivision be completed by Burrington Group. Ayes: all. Carried.

Clerk comments: Helle discussed attendance at the Maquoketa River WMA meeting and a hole that had been burned into table in community center.

Council comments: Tuel asked if a Memorial Hall contract had been signed for the Bellamy Brothers concert. Mayor Burger gave an update on the Bridal Room at Memorial Hall. He also will be reaching out to engineer concerning the payouts for 136 project
