FOOD VENDOR INFORMATION

Available on a first come basis as long as the food offered is approved by committee. Food vendor price is \$ 500.00. Paid with application and with a certified check or money order. **No refunds given.**

TERMS OF CONTRACT FOR FOOD VENDORS

1. All proceeds from your sales belong to the vendor. No commissions will be assessed. Vendors are responsible for collecting and paying Georgia sales tax and reporting earnings to the IRS.
2. **Insurance**—Vendors are expected to carry their own insurance coverage to protect their merchandise from damage, loss or theft incurred while participation in our Fair. No insurance will be supplied by the Fair. You will need to provide insurance information when you send in your forms. Request a certificate of insurance from your company. Judy Bryson will be available to help you with this if you need more questions answered,
3. All food items made available for sale along with prices must be approved by the food committee prior to set up. These prices are to be properly displayed at all times.
4. No vendors or their representatives shall conduct themselves in an offensive manner to general standards of decency of good taste. Entrance to the Fair and parking will be only with approved passes.
5. No smoking or alcohol is allowed on fairgrounds. The county has brought it to our attention that several of our food vendors clothing was not clean. Please make sure that before you start serving you put on a clean shirt and hat if you are wearing a hat and not a hair net. They will be enforcing this in 2020. This is a county ordinance that must be observed by all vendors.
6. Please bring trash bags and clean up your area on a daily basis. When vacated, vendor spot must be left clear of all paper, packing materials, and other refuse. **DO NOT LEAVE A MESS FOR SOMEONE TO CLEAN UP. YOU WILL NOT BE INVITED BACK. TAKE TIME AND CLEAN YOUR MESS UP.**

7. You are responsible for contacting Habersham County Health Department a minimum of 30 working days prior to the opening date of the Fair.
8. Set up dates are Wednesday, September 9, and Thursday, September 10. Please contact Judy Bryson at 706-499-0993 to schedule a set up time. She will arrange to be at the fairgrounds to meet with you. We will try to set up so that you will not have to be asked to move after set up so please work with us about the setup order. Location is **not** guaranteed. Do not ask. Do not expect to be in the same spot as previous year.
9. You must furnish your own hoses and power cords. It is your responsibility to make sure they are used properly and placed as to not be a hazard to fair attendees.
10. No ice is available for vendor use. Ice machine in kitchen is for use of Fair committee.
11. **NO Pets of any kind are to be on the property at any time during the Fair.**
12. **You are responsible for completing a sales tax return and paying the proper taxes.**

FAIR DATES THIS YEAR ARE SEPTEMBER 11- SEPTEMBER 19, 2020.

Food vendors only will be allowed inside the back gate at 3:00 pm on week days and Sunday food vendors allowed at 10:00am on Saturdays.. If you have a problem and need to get in at a different time, please contact Brenda Kinsey 706-768-6890 and arrangements will be made to help you.

Thursdays have been our low night at the gate and with vendors. So this year we are trying something new. **\$2.00 Thursday.** We will promote this night in all our advertising. We are asking you to come up with a food item that you can sell for \$2.00. Please call Brenda or Judy for questions.
