3/26/2018

Sgt. Warner and Deputy Schuerman responded to Jerusalem in regards to a male juvenile making threats towards Beallsville School. Investigation lead to an arrest of the juvenile and he was transported to Sargus Juvenile Detention Center.

The Monroe County Sheriff's Office received a complaint from MCJFS in reference to a possible child abuse case in Sardis. Deputy Weekley was assigned the case and is currently under investigation.
