



BINDER / ENDORSEMENT REQUEST FORM

If your renter has decided to provide you with a binder or endorsement that extends coverage to the vehicle and to your dealership from the renter's personal policy, you must use the Insurance Binder / Endorsement Request Form. This form outlines what information a Binder or Endorsement **MUST** include.

If the renter's insurance agent cannot supply a binder with all of the required information listed on the Insurance Binder / Endorsement Request Form, your renter must purchase the CHOICE insurance online.

If the renter's insurance agent can produce a binder with all of the required information, be sure they send a **signed** copy of the Insurance Binder / Endorsement Request Form along with the actual Binder.

Note: A CERTIFICATE or copy of a DECLARATIONS PAGE, or insurance CARD is not sufficient. Also, each authorized driver must provide a binder or endorsement for the rental.

Your insured, _____ is currently planning on renting a motorhome from **Rolling Vacation, LLC** (“Dealer”). Your insured has chosen to have his/her personal vehicle insurance as **primary** insurance for the period of this rental. In order to fulfill the request of your insured, we require a Binder. The binder or endorsement should cover the vehicle and name the Dealer as an additional insured. In order to satisfy our requirements, the insurance provided by you must include **primary** comprehensive and collision coverage and **primary** liability coverage. **This promise of primary insurance coverage may amend the terms of your policy.**

Your policy must cover up to the actual cash value of the rented motorhome. The estimated value of the motorhome your insured will be renting is \$ **\$165,000.** The limits of liability coverage must be at least the minimum limits as required by any applicable compulsory or financial responsibility law. The loss payee should be listed as **Rolling Vacation, LLC.** Any collision or comprehensive deductible shall not exceed \$1000.00. **If your company cannot provide coverage, insurance can be obtained through the Dealer’s resources.**
