PARK BOARD

No one available to provide update

Per Ault, Park Board has arranged for Catrina Avery to provide an update on a regular basis to the Board of Alderman.

EMERGENCY MANAGEMENT

Per Ault, the Heritage Reunion Festival went really well. They had five medical calls, but none of them were serious. Four of them may have required an ambulance, but due to the cart they were able to obtain, they were able to transport emergency equipment to the subjects averting the need of an ambulance. One person also forgot where they parked and could not locate their vehicle. They utilized Skylab and was able to locate the car. It was estimated approximately 30,000 to 35,000 people were at the festival on Saturday and approximately 10,000 to 11,000 on Sunday. This was the largest turnout the festival has had.

Ault stated Emergency Management is conducting monthly meetings to ensure everything moves forward smoothly.

Icenhower asked Ault who authorized the testing of alarms without prior notice. The alarms are supposed to only be tested on Wednesdays at 10:00 a.m. unless prior notice is given and citizens can be notified. Several citizens had called in concerned when they heard the alarm sounding. Per Ault, she is not sure what permission Ted Wolf had received but did state they needed to test their new radio.

POLICE DEPARTMENT

Festival went well with very few calls for service. There were a few in-house issues that arose which will be worked on for next year.

Department received lots of positive comments on the uniforms they wore at the festival. Police may utilize this uniform for Spring/Summer as they are much cooler to wear.

Department had a few arrests for theft from Kum and Go and a DWI but nothing major to report.

CITY CLERK

First round of ARP funds received. Need Board members to decide and prioritize how these funds are to be utilized.

Greene County Department of Social Services sent out notice to the city to see if our water/sewer department wanted to coordinate with them for residents who are in arrears on their bills. Information was given to the Water Department to see if they wanted to participate.

COMMITTEE REPORTS

Sewer and Public Works

Roe provided an update on the CC Lift Station project. Handout is attached to minutes. Icenhower asked the Mayor who authorized the dumping of outhouses from festival in our sewers. Mayor stated he was contacted by someone with the Heritage Reunion and was told Hokanson okayed it as long as the Mayor was good with it. Per Icenhower, Mayor does not have authority to make this decision, but Mayor insisted he did as he considered this an emergency situation. Icenhower stated Hokanson spoke with Leon Burrell and Burrell was told he could not dump in our sewers. Danderson advised discussions on outside disposal into our sewers was brought to the Board in February and it was decided we would not accept them.

Mayor apologized to Board for allowing them to dump and said due to what he knows now he would not have proceeded as he had. Board accepted his apology.

Ault announced Ward I is having a neighborhood party this coming Saturday. Will be outside at the Pavilion.

Mayor Report

During setup at the festival one of the vendors blocked Main Street for a couple of hours. This issue will be addressed so there will not be a repeat occurrence next year.

Questions were brought up on process for vendors on private property. Per the City Clerk, the vendor needs written permission from the property owner to set up on their property. They need to fill out a Special Events License at City Hall and pay \$10. If food is to be served, they also need a county health permit.

Complaints / concerns were expressed this week regarding the old mill drainage at Teal's Greenhouse. Water drains into a ditch, causing some standing water and odor issues. They asked if the City could enclose this area but were advised due to financial constraints at this time, the City would not be able to do this.

A request was also made for a streetlight at the corner; however, as there is another light within 300ft of requested location, we would not install another one.

Danderson brought up that this was the last Board meeting Dana would be attending as a City Clerk as her last day is October 1st. Danderson thanked Dana for her years of service and all her hard work. Job well done.
