I/We know that participation in baseball or softball may result in serious injury and protective equipment does not prevent all injuries to players, and do hereby waive, release, absolve, indemnify and agree to hold harmless the CRAA, the organizers, sponsors, supervisors, participants, and persons transporting my/our child whether the result of negligence or for any other cause.
- 3. I/We agree to return upon request the uniform and other equipment issued to my/our child in a good condition as when received (except for normal wear and tear).
- 4. I/We will furnish a birth certificate for the above-named player to the CRAA as requested.
- 5. CRAA Code of Conduct-No board member, manager, coach, parent, spectator, or player shall at any time:
  - Lay a hand upon, push, shove, or threaten to strike, heap personal, verbal, or physical abuse upon any official, board member, manager, coach, parent, spectator, or player for any reason.
  - Be guilty of an objectionable demonstration of dissent at an official's decision by throwing of gloves, helmets, hats, bats, balls, or any other forceful unsportsmanlike action.
  - Be guilty of any profane, obscene, or vulgar language in any manner at any time.
  - Appear on the field of play, stands, or anywhere on the Chicago Ridge Park District playing fields while in an intoxicated state. Intoxicated will be defined as an odor or behavior issue.
  - Be guilty of gambling upon any play or outcome of any game with anyone at any time.
  - Smoke while on the playing fields or in the dugouts during games and practices.
  - Be guilty of tampering or manipulating any league rosters, schedules, draft positions or selections, official score books, rankings, standings, financial records, or procedures.

The Board of Directors will review all infractions of the CRAA Code of Conduct. Depending on the seriousness or frequency, the board may assess additional disciplinary action up to and including expulsion from the league.
