

**ORDINANCE NO. 2014-3****ORDINANCE LEVYING AND ASSESSING TAXES OF THE  
PALOS FIRE PROTECTION DISTRICT,  
COOK COUNTY, ILLINOIS FOR 2014**

**BE IT ORDAINED** by the Board of Trustees of the Palos Fire Protection District, Cook County, Illinois, as follows:

**Section One:** That the sum of **SIX MILLION THREE HUNDRED AND SIXTY TWO THOUSAND SIX HUNDRED AND FORTY-SEVEN DOLLARS AND NO CENTS (\$6,362,647.00)** be and the same is assessed and levied from and against all taxable property within the limits of the said Palos Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2014, and which ordinance was duly published as provided by law, and the specific amount hereby levied is set forth under the column entitled "Amount To Be Raised By Tax Levy," as follows:

**PENSION FUND**

Pension Fund Levy

\$867,647.00

The foregoing amount is hereby levied for pension purposes pursuant to the provisions of 40 ILCS 5/4-118.

This sum includes \$47,647.00 attributable to the passage into law of P.A. 93-0689.
