4. Rentor (Vendor) shall not assign or sublet the premises or allow any other person to occupy the leased premises without express written consent from the Fair Management.
5. Rentor (Vendor) shall not make any material or structural alterations to the leased premises without prior written consent of the Fair Management.
6. Rentor (Vendor) shall comply with all building, zoning and health codes and other applicable laws for the use of said premises.
7. Rentor (Vendor) shall not conduct on premises any activity deemed extra hazardous, a nuisance or requiring an increase in fire insurance premiums.
8. Rentor (Vendor) shall not allow pets on the premises.
9. It is understood and agreed that this lease is for the sale of food and non-alcoholic beverages and no other products.
10. In the event of any breach of payment or any other breach of this Lease, the NCA District Fair shall have full rights to terminate this lease in accordance with state law; to reenter and reclaim possession of the premises, in addition to such other remedies available to Rentor (Vendor) arising from said breach.
11. It is understood that booths may stay open at any hours desired between 8:00 a.m. and 8:00p.m. daily.
12. The Rentor (Vendor) shall be responsible for filing and paying Arkansas sales tax as required by law.
