- Terry D'Andrea introduced Alec Benoit, Manager for Bartlett Tree Experts.
 - O Alec discussed the services that Bartlett provides and how he is working with the Board on current and future plan to maintain the trees in the community. A wide range of topics were discussed i.e., volcano mulch, emerald ash bug, spotted lantern fly, black knot and preventive maintenance just a few topics among a Q & A session with Alec.

- 39 CRR
