Tire Day Update:

Allan said the day went very well, he thanked the Sheriff's Dept for bringing 4 people who worked very hard, they handled about 700 tires that day.

Assessor's Update:

The State review of the tax roll has been completed.

Miami Park Erosion Update:

We don't have any information from the Public Hearing to move forward on yet. We hope that maybe by next month we will have something.

The Miami Park Stairs Association wants to know our feelings about them trying to get more beach. Going from 15 ft to 20 feet to get this they would have to shrink their lower walkway, which is above the revetment, from 10ft to 5ft. The board didn't have any objection to this, even though it isn't public property.

• Nature Preserve Project & Invoice Approval:

We have two progress invoices that have been reviewed by the engineer and recommends them for approval. Allan presented progress Invoice number one for \$14,400.00 and progress Invoice number two for \$61,762.50. Cheri made a motion to approve payment for both invoices from Davis Landscaping & Home Improvements LLC for the total amount of \$76,162.50. Supported by Kenny. No further questions or discussion. Hearing None. All Votes in Favor. Morion Carried.

• Senior Service Survey Results and Discussion:

Allan discussed the survey results; he was impressed that 33 individuals took the time to spell out their reasons for going to South Haven. Allan asked for permission from the board to go ahead and set up a meeting with Van Buren County South Haven Senior Center Director.

• Open Positions update and Procedure going forward:

Job descriptions are running for two weeks in the South Haven Tribune and the Allegan County News. We have received some interest in the Cemetery Sexton position. Allan presented a compensation range for the Sexton position of \$20,000 to \$25,000.00, this does not include the digging of the graves. Kenny made the motion to approve \$20,000 to \$25,000 for the Cemetery Sexton position, which is not digging of the graves. Supported by Cheri. All Votes in Favor. Motion Carried.

Allan made a motion for the Transfer Station position hourly rate from \$20 to \$22 per hour. Supported by Kenny. No further discussion. All Votes in Favor. Motion Carried.
