I. MEETING TO ORDER/ROLL CALL

**A. 5486 Gill Street Water Sewer Line**

Quotes were presented by Mr. Nash on behalf of his client and presented the option of boring under the road for the Sewer Line to the council.

DPW Supervisor Honnold stated a 4' Line would be adequate if boring was completed.

Don resident next to property asked where the water line comes in at.

Mr. Nash stated the amount she was willing to pay was based off a percentage and approximately 38% when the project was at \$20,000.00.

**MOTION** by Jones, supported by Weaver, approved the following due to Ordinance 32.8 and 32.9 ambiguities the Village is willing to work with the homeowner at 5486 Gill Street, the total cost of Sewer Line installation from the Sewer Main to the property line not to exceed \$12,000.00, which Rose Mary Evans will pay \$4,560.00 to the Village of Dryden, any and all expenditures above this amount will fall onto the Owner of the Property for the Sewer Line Installation.
