Table of fees, payments and sums fixed and settled under Section 34 of the Burial Act 1852, by the Parish Council of Tideswell, acting as the Burial Authority for the Parish of Tideswell.

### **1. INTERMENTS**

(Note – Tideswell Parish Council does not provide a grave digging service for burials)

**All memorials in 3 & 4 above must be secured in accordance with the NAMM Code of Practice.**

**5. SCATTERING OR INTERMENT OF ASHES**

(Note – Tideswell Parish Council does not provide a grave digging service for interment of ashes)

**7. ELIGIBILITY**

Interments for non-parishioners are to be discussed with the Clerk.

The foregoing fees are to be applied where the deceased has lived in the Parish of Tideswell for 12 months prior to his/her interment. This is to be verified by inclusion on the electoral role.

In consideration of special circumstances e.g. where a Parishioner of Tideswell has not lived in the village for 12 months prior to his/her interment, interment may be permissible at the Clerk's discretion, subject to a maximum 300% premium (ie 4 times standard rate for parishioners) to the foregoing fees (including the Clerk's fee), payments and sums.

*At a meeting of the Parish Council of Tideswell held on the 11<sup>th</sup> day of May 2015, the foregoing fees, payments and sums, payable under Section 34 of the Burial Act 1852, are hereby fixed and settled by the said Parish Council, to commence from 11.06.24*
