Harry stated that the delinquent sewer agreements DELINQUENT could not be prosecuted in Small Claims Court, so if we SEWER decide to sue, we might as well go ahead and file in CONNECTION District Court.

ACCOUNTS

Harry stated he had talked with the Assessor and the Treasurer about adding sewer charges to the tax bill. He stated he was looking into the proper procedure.

 $\,$ Harry was asked to prepare a statement for Neldon Neldon Lemon Lemon to sign stating he would give the district an easement EASEMENT to the existing sewer.

Dan Holyoak stated he had went to Price and NEW OFFICE met with Joel Johnson of Zions Bank. Harry is in the processBUILDING of preparing a deed to both Districts. He also reported we were in the process of getting Title Insurance.

George reported that Dale had drawn a tentative plan for remodelling and adding extra office space needed. Dale has taken John Lillibridge to look over the space and give an estimate, then he can draw up specs and put the remodelling out for bid.

Dan stated we should petition the City to go to CITY COUNCIL the Community Impact Board for funds to take the sewer line to the golf course, and to meet with the City Council privately and discuss this, in order to protect the City's springs and water sources. Harry suggested Jim Adamson be invited to suggest water source protection. Linda suggested we find out how much the sewer line would cost, and the number of feet involved.
