Dana Tuttle from the Plumbers Examining Board regarding overlapping jurisdictions.

David and Dana will work on a draft Memorandum of Understanding that will clarify the work which can be undertaken by a licensed plumber on a pump system and by a licensed pump installer on internal plumbing.

Points of discussion the Boards appear to have agreement on include:

- A plumber's license is required for the installation of water treatment equipment (Per the Internal Plumbing Code which has been adopted by State Law).
- Internal plumbing begins 2 feet outside a building per the Internal Plumbing Code.
- The MOU will include language that allows pump installers to install inline type filters that don't include air gaps, back flow prevention, etc.
- Journeyman Plumbers can do pump work, all work on pumps must meet the standards in the Well Drillers and Pump Installers Rules. A Master Plumber must be responsible for the work of a Journeyman.
- Pump Installers can install the water line from the well, the pressure tank and connect to the distribution system. The standards of the Internal Plumbing Code must be met.

The Safe Drinking Water Act: Protecting Drinking Water for Life

The Safe Drinking Water Act (SDWA) was originally passed by Congress in 1974 to protect public health by regulating the nation's public drinking water supply. The law was amended in 1986 and 1996 and requires many actions to protect drinking water and its sources:

- *rivers
- *lakes
- *reservoirs
- *springs
- *ground water wells

(SDWA does not regulate private wells which serve fewer than 25 individuals.)

What Does EPA Do Under the SDWA?

SDWA authorizes EPA to set health-based standards for drinking water to protect against both naturally-occurring and man-made contaminants that may be found in drinking water. EPA, states and water systems then work together to make sure that these standards are met.

Millions of Americans receive quality drinking water everyday from their public water systems, (which may be publicly or privately owned). Nonetheless, drinking water safety cannot be taken for granted. There are a number of threats to drinking water:

improperly disposed of chemicals;

animal wastes;

pesticides;

human wastes:

wastes injected deep underground; and naturally-occurring substances can also contaminate drinking water.

Likewise, drinking water that is not properly treated or disinfected, or which travels through an improperly maintained distribution system, may also pose a health risk.

Where Does SDWA Apply?

SDWA applies to every public water system in the United States. There are currently more than 160,000 public water systems providing water to almost all Americans at some time in their lives. Originally, SDWA focused primarily on treatment as the means of providing safe drinking water at the tap. The 1996 amendments greatly enhanced the existing law by recognizing the following as important components of safe drinking water:

source water protection,

operator training,

funding for water system improvements and public information.

This approach ensures the quality of drinking water by protecting it from source to tap.

MGWA Asking Customers to Test Water ...

Members of the MGWA are encouraging their customers to test their water whether it be from a spring, a dug well, a drilled well or another source.

Only by testing, can customers be assured a safe drinking water supply that is so important to the health of their family and animals.

Please encourage everyone to get their water tested.




