We further agree to release from liability and to indemnify and hold harmless the facilities herein described, it's owners, agents, landowners, employees, event officials, organizers and volunteer workers from any and all claims, losses, and liabilities (including costs and attorney's fees) that I/we may now have or which I/we may hereafter have for property damage, injury or death, which I/we may suffer or for which I/we may be liable to others, arising out of or in any way connected with my/our preparation or practice or participation at the above facilities whether as part of a group or as an individual or from any use whatsoever of the premises, facilities or services of the above described facilities. This release and indemnity agreement shall apply to all claims based upon negligence and any other theory of recovery, except claims based upon willful or intentional misconduct.
