# TOWN OF MAPLE CREEK December 11th, 2017 Town Board Meeting Minutes

### Call to order and Pledge of Allegiance by Chairman Gitter

Chairman Gitter called the December 11th, 2017 Maple Creek Town Board meeting to order at 6:30 p.m. and led the Pledge of Allegiance.

**Verify open meeting notices, roll call, approval of agenda order (stands as is unless motion for change)** The agenda for these minutes was posted at the three Town posting boards on Saturday, December 9<sup>th</sup>, 2017. *Elected Officers present*: Paul Gitter, Mike Bruette, Dalton Korth, Larry Katerzynske, Tory Much, Steve Janke. *Others present*: Glen Janke, Deb Radmer, Dennis Handschke, Chris Thompson, Officer Quella.

#### **Treasurer's Monthly Report**

The balances for all accounts as of November 30th, 2017, (reported on December 11th, 2017) are as follows: Checking - \$12,958.74; Investment Savings - \$78,548.37; and Town CD's - \$125,000.00. Total town funds now are \$216,507.11. Town received state shared revenue payment.

**Outagamie County Sheriff's officer report (if in attendance)** Resident turned in illegal dumping, which officers apprehended. Suspicious duffel bag of clothing was found in the township; possible drug paraphernalia included. Patrols were stepped up in the area.

#### Specific matters for discussion and possible action:

**A. Emergency Management base document and training-** Clerk distributed the county document to board members. Clerk will work with Chairman to "fill in the blanks" for board approval in January. The 3-day onsite course will not be attended. Board members will instead take the recommended online courses beginning in the new year.

**B. Tax intercept program for unpaid property taxes-** Clerk spoke with state reps for the TRIP program. It can be used to intercept tax refunds for property taxes. Board wondered what changes to Town ordinances might be needed – clerk will check into legality of doing such a thing.

**C. Current UDC inspector – replace?** Board, clerk and property inspector feel our current UDC inspector is difficult to contact. Chairman will contact Bear Creek's UDC inspector to see if he has interest in taking on Maple Creek as well.

**D. Dog license software fees increase, can we do anything about it?** Treasurer explained that the software fees also include tax payment receipting, not just dog licensing. She will also inquier of our bank if they will absorb the \$200 fee for passing through payments.

**E.** Chairman township tour with Steve Swanson- address various zoning violations – Chairman and County zoning administrator made several visits to properties in violation of zoning laws, including those missing building permits and with excessive vehicles. The visits were deemed "productive."

**F. Ditch water on Hoffman Road-** Water has begun to stand in ditch on north side of Hoffman Road, where a resident stopped his clearing of the ditch. County is working on fixing this problem.

**G. Approval of Gary Coroneos as Election inspector for 2018/2019 term-** <u>Gitter made a motion,</u> <u>seconded by Korth, to approve Gary Coroneos to serve as an Election Inspector for the 2018/19 term.</u> <u>MOTION CARRIED.</u>

H. WTA district meeting, Marion. Friday, January 26, 8:45-3:15: BOR Training. \$60/per- Clerk explained this meeting also covers needed Board of Review training for the next two years. <u>Gitter made a</u> motion, seconded by Bruette, to send 3 people to WTA meeting in Marion on January 26 at cost of \$180. MOTION CARRIED.

**Report of officers:** <u>Clerk</u>: New voting machine has arrived. <u>Cemetery</u>: none <u>Constable</u>: 1 dog delivered to the pound. <u>Building Inspectors</u>: 1 permit for outbuilding. <u>Raft</u>: none. <u>Planning Commission</u>: none.
