**NO tables or chairs will be provided to outside Exhibitors.**

**Registration and fee must be postmarked prior to July 1<sup>st</sup>.**

**Any registrations and/or payments received postmarked after July 1<sup>st</sup> will be subject to additional pricing as stated above.**

**The Dakota Thurston County Fair Board agrees to:**

1. Provide tables, chairs, electricity, and WIFI connection for Indoor Exhibitors.
2. These items will not be provided to outdoor Exhibitors.
3. Provide night watch for security Wednesday night thru Sunday for Indoor and Outdoor Exhibitors. Times are subject to change.

**Exhibitor agrees to:**

1. Set up Tuesday **July 28<sup>th</sup>** 5:00-8:00pm or Wednesday **July 29<sup>th</sup>** after 9:00 am. Teardown after 6:00 pm on Sunday **August 2<sup>nd</sup>**.
2. The exhibitor agrees to the following concerning liability. The Dakota Thurston County 4-H and Agricultural Society, (Dakota Thurston County Fair) expressly refuses to assume any liability for injuries to any person or damage to property shall be asserted or suit instituted or maintained against the said Dakota Thurston County 4-H and Society, its officers, agents, or employees for said cause by any person having privilege to exhibit of license to operate on the fairgrounds or occupying any space thereon. And it is a part of the consideration for each license or privilege granted by the Dakota Thurston County Fair that such claims for injury or damage to property are specifically waived.
3. The Dakota Thurston County Fair Board reserves the right to change the above times, charges or dates at any time. If changes are made, exhibitor will be notified and the option given for a refund of payment if changes are not acceptable.
