There was also discussion regarding when the County Bids are presented and can that be given to the Board. Supervisor May discussed with the Board, that Laura Kirsch stated that there is an overage of \$493.50 in Retired Judge Smiths account. The account is closed, we will have to leave the monies for 3 years, then it will come back to the Town.

Next Month meeting at 7:30pm the books of Judge Ficarella will be reviewed.

<u>Town Clerk Report-</u> The Towns total revenue for the month of December 2018 was \$177.00. \$117.00 for dog licenses, \$10.00 for late fees, and \$50.00 for Registrar. We had 3 new dog licenses and 9 renewal licenses. To the general fund, Supervisor May \$98.00, Dogs were \$38.00, \$10.00 in late dog license fees, and \$50.00 for Registrar. We disbursed \$65.00 to Wyoming County, \$14.00 to Ag and Markets for dogs.

Next year Real Property will utilize a new vendor to print and send out the Tax Bills. This year, all bills were sent out, regardless if the taxes were in escrow. This was a bit alarming to some Town Residents.

2018 Tax Books were review by the Town Board without issue.
