

Means: The Rules committee (schedules bill to be heard by entire chamber) approved the bill to be placed on the calendar to be heard by the entire Senate.

Means: The committee substitute (CS) itself passed by Resources committee (RES) was adopted by the Senate.



Means: The bill had a 1st reading. It doesn't say House or Senate but we know it is House from the bill number (AB = Assembly/House bill). All new bills must be sent to the printer to be printed out.

02/09/21	From printer. May be heard in committee March 11.

Means: Bill was printed. The committee hearing date listed is the earliest expected date the bill could have a hearing based on timing at each stage of the process and when the committee meets.

Means: The bill will be referred to two committees. The first is Public Safety (PUB. S.). The 2nd is Business & Professions (B. & P.).

03/23/21	Re-referred to Com. on PUB. S.
03/22/21	From committee chair, with author's amendments: Amend, and re-refer to Com. on PUB. S. Read second time and amended.

Means: The author submitted an amendment to the committee chair. The bill was pulled from committee, had the amendments added, was read a 2nd time to approve them in the House and was sent back to committee in its updated form.

In committee: Hearing postponed by committee.

Means: Bill had a hearing listed but it was postponed. In this case, the committee postponed it. The author can also request a hearing be cancelled or postponed.

Means: There was no action in the Public Safety committee, so a vote was made to withdraw it and refer it to the 2nd committee (Business & Professions) instead.

Means: Appropriations passed the bill with a Do Pass vote of 16 Ayes and 0 Noes on May 5.

05/06/21	Read second time. Ordered to Consent Calendar.

Means: The full House read the bill a 2nd time. It was sent to 3rd reading.

05/13/21	Read third time. Passed. Ordered to the Senate. (Ayes 75. Noes 0. Page 1408.)

Means: The bill passed the House with a vote of 75 ayes and 0 noes. The page number is the journal page.

05/13/21	In Senate. Read first time. To Com. on RLS. for assignment

Means: The bill had a first reading in the Senate where it was read by title, and then sent to Rules committee. Rules determines which committee a bill will go to.

05/27/21 Referred to Coms. on B., P. & E.D. and JUD.

Means: The Rules committee referred the bill to 2 committees. The first is Business, Professions and Economic Development.

06/08/21	From committee chair, with author's amendments: Amend, and re-refer to committee. Read second time, amended, and re-referred to Com. on B., P. & E.D.

Means: The author added additional amendments, which had a 2nd reading in Senate to approve and were added to the bill and sent back to committee.

06/14/21 In committee: Hearing postponed by committee.

Means: Hearing was postponed for now, this time by committee.

06/30/21 From committee: Do pass and re-refer to Com. on JUD. (Ayes 13. Noes 0.) (June 30). Re-referred to Com. on JUD.

Means: Business, Professions and Economic Development passed the bill with 13 ayes and 0 noes on Jun 30 and then referred it to Judiciary.

07/01/21 From committee chair, with author's amendments: Amend, and re-refer to committee. Read second time, amended, and re-referred to Com. on JUD.

Means: Author again amended the bill in committee.

07/14/21 From committee: Amend, and do pass as amended and re-refer to Com. on APPR. (Ayes 11. Noes 0.) (July 13).

Means: Judiciary passed the bill with an amendment. Then they voted to send it Appropriations (wasn't on original committee list so last committee had to approve).

07/15/21 Read second time and amended. Re-referred to Com. on APPR.

Means: Bill was read a 2nd time by the Senate where the committee amendments were approved, and it was sent to Appropriations.

08/16/21 From committee: Be ordered to second reading pursuant to Senate Rule 28.8.

Means: Bill was removed from committee due to no action and sent to 2nd reading.

Means: Bill had 2nd reading by Senate.

08/30/21 Read third time. F	Ordered to the Assembly. (Ayes 39. Noes 0.)

Means: Bill passed the Senate.

08/31/21	In Assembly. Concurrence in Senate amendments pending. May be considered on or after September 2 pursuant to Assembly Rule 77.

Means: House received the bill. They still need to approve the Senate amendments, which may take place starting Sep 2.

09/01/21	Senate amendments concurred in. To Engrossing and Enrolling. (Ayes 78. Noes 0.).
09/01/21	Assembly Rule 77 suspended. (Ayes 54. Noes 16.)

Means: House decided to suspend its rule to wait until after Sep 2 and go ahead and concur with the amendments. The amendments were enrolled or added to the bill and printed.

Means: The bill passed committee with an amendment. It was then sent to the Committee of the Whole, which is a committee of the entire House where debate on the bill takes place.

03/25/2021 House Second Reading Passed with Amendments - Committee, Floor

Means: The bill had a 2nd reading where the committee amendment was approved along with a new amendment introduced in the entire House.

03/26/2021 House House Third Reading Passed - No Amendments

Means: House passed the bill. No new amendments were introduced.

03/29/2021 Senate Introduced In Senate - Assigned to Agriculture & Natural Resources

Means: Senate received the bill and referred it to committee.

04/22/2021 Senate Committee on Agriculture & Natural Resources Refer Amended to Senate Committee of the Whole

Means: Committee passed the bill with amendments and sent it to the Committee of the Whole where full Senate will debate it.

04/27/2021 Senate Second Reading Passed with Amendments - Committee, Floor

Means: Senate had a 2nd reading and approved both the committee amendment and a new amendment introduced in the full Senate.

04/28/2021 Senate Senate Third Reading Passed - No Amendments

Means: Senate passed the bill with no additional amendments.

04/29/2021 Senate House Considered Senate Amendments - Result was to Concur - Repass

Means: House approved of the Senate's amendments and repassed the bill.

05/11/2021 House Signed by the Speaker of the House
05/11/2021 Senate Signed by the President of the Senate

Means: Bill must be signed by the leaders of both the House and Senate to verify that both passed the bill.

Vote to Draft

Means: The Government Administration and Elections (GAE) committee voted to get the draft of the bill. CT bills are introduced with just a summary, not actual texts. The committee must vote to approve drafting the bill before proceeding with action on it.



3/3/2021

Drafted by Committee

Means: The bill draft was created and posted.



3/4/2021

Referred to Joint Committee on Government Administration and Elections

Means: Draft was sent to the committee. In CT, bills are referred to a joint committee, meaning that both the House and Senate use the same committee.



3/5/2021

Public Hearing 03/10

Means: Public hearing was held on the bill.



3/30/2021

(GAE)

Joint Favorable

Means: The committee passed the bill. Joint just refers to being from joint committee.

3/30/2021

(LCO)

Filed with Legislative Commissioners' Office

Means: The bill was sent to the LCO, which reviews the bill and makes sure it is constitutional and it doesn't violate any laws.



4/9/2021

(LCO)

Referred to Office of Legislative Research and Office of Fiscal Analysis 04/14/21 5:00 PM

Means: Bill was sent to Office of Fiscal Analysis to get a fiscal estimate of the bill (what it will cost to enforce) along with the Office of Legislative Research to get a general summary of the bill.



4/15/2021

(LCO)

Reported Out of Legislative Commissioners' Office

Means: LCO sent the bill back to the legislature with its reports.

4/15/2021

Favorable Report, Tabled for the Calendar, House

Means: Action on the bill was temporarily tabled in the House. Favorable report refers to the Government Administration & Elections committee report.



4/15/2021

House Calendar Number 332





INTRODUCTION

Currently, the Nebraska Brand Committee "consist[s] of five members appointed by the Governor." Neb. Rev. Stat. § 54-191(1) (Cum. Supp. 2020). You introduced an amendment to LB 572, recently adopted on General File, which would amend this statute to provide that appointees to the Nebraska Brand Committee are "subject to confirmation by the Legislature." AM686. In connection with this pending legislation, you have requested our opinion on three questions relating to the appointment of members of the Nebraska Brand Committee and the application of the appointment powers granted the Governor in Neb. Const. art. IV, § 10. Your specific questions are:




