The **National Motor Vehicle Title Information System**, perhaps better known by the acronym **NMVTIS** is a quite valuable investigative resource.

There is a **Law Enforcement** only version, **NMVTIS-LE** for criminal investigative purposes and fraudulent inquiries.

In light of the recent flooding from Hurricane Harvey and thereafter from Hurricane Irma, it is anticipated that many thousands of damaged vehicles may become the source of fraudulent disposition efforts.

The annual Hurricane Season continues through December each year and we may certainly anticipate additional weather related issues yet to come.

The **NMVTIS L.E.** data base includes a link into the secure **NICB Flood Damaged Vehicle** data base.

The **Regional Organized Crime Information Center**, and the **Regional Information Sharing Systems** work with the **NMVTIS** as a partner resource for Law Enforcement Agencies and their Investigators.

To access the Law Enforcement version of **NMVTIS**, that if **NMVTIS-LE** you must first have a secure **RISS** Account.

Most of you receiving this message will have already secured same via your agency and employment position.

For any of you that may not yet have a secure **RISS** Account, you may secure same by utilizing the below **On Line Registration** procedure-
