Upon application and payment of the applicable fee, a Non-Resident Daily Motor Vehicle Permit shall be issued by the Clerk-Treasurer of Beverly Shores. The following restrictions and exclusions apply:

1. A Non-Resident Daily Motor Vehicle Permit is non-transferrable and is valid only for vehicle on this application.
2. A Non-Resident Daily Motor Vehicle Permit is valid for one (1) day and that day shall be displayed on permit. Date must be written legibly in permanent ink.
3. A Non-Resident Daily Motor Vehicle Permit must be displayed hanging on rearview mirror.
4. A Non-Resident Daily Motor Vehicle Permit is valid for parking at Rebora Plaza **ONLY**. Rebora Plaza is located at the furthest point of Broadway at Lakefront Drive.
5. A Non-Resident Daily Motor Vehicle Permit is not valid on weekends or holidays.
