Program Update- Federal Update

House of Representatives

- Slim majority made even tighter by Biden Administration nominations
- Republicans dealing with fallout from Impeachment, Capitol Insurrection, President Trump

Senate

- 50/50 Democratic majority with Vice President Harris
- Future of the Filibuster
- Fiscal Year 2022 Budget
 - Sequestration budget caps are gone
 - Role of congressional earmarks
 - Three month delay is compounded by congressional Covid-19 operating procedures

Defense Budget

- Impact of DMAG review and flat line request of \$705B?
- Whispers of potential BRAC request. Strategic basing recommendations influenced by quality of education; cost savings; climate change and alignment to the National Defense Strategy




Program Update - FY22 DoD Budget

- Expect PBR to Congress May 3...may "flat-line" DoD at ~\$705B
- DepSec Hicks Conducting Six Program-Review "DMAGs"
 - Navy Shipbuilding
 - Nuclear Triad Recapitalization
 - Long-Range-Strike
 - Tactical Aircraft (F-35; KC-46; MQ-9)
 - Climate Change
 - "Build Back Better"
- All Six DMAG Reviews Will Also Ask Three Questions:
 - What low-value, legacy fleets can be divested, free up savings for modernization?
 - What can be done to increase Pacific-deterrence against China?
 - What can be done to accelerate Unmanned/Autonomous platforms?
- Air Force May Propose Additional Aircraft Retirements: A-10, KC-10, KC-135, that were not approved by Congress in 2021
- Services POMs For FY23 Due to OSD June 2021 = very tight turnaround!

 - 2 additional recognition programs; i.e. MoMC, Veterans Day

Eglin AFB / Hurlburt Field DoD SkillBridge

Partnership Need/Requirement

■ Eglin AFB/Hurlburt Field Community has a critical shortage of a cleared workforce with technical/professional skills.

Partnership Description

Through the Tri-County Partnership Initiative (TCPI), Eglin AFB/Hurlburt Field signed an MOU with the local workforce development board to create a Career Readiness Assistance Work Group (WG) to deliver enhanced transition services, including participating in internships under the DoD SkillBridge Program.



Three TSM's successfully completed DoD
SkillBridge internships and were hired with local contracting company MAG Aerospace



■ How the Partnership Works

Installation Education Centers refer Transitioning Servicemembers (TSM's) applying for a SkillBridge internship to the local workforce development board, where Local Veterans Employment Representatives match them with the community's local businesses for an internship.

Partnership Benefits

■ Significant to AFCP and its mission, each TSM that receives enhanced career readiness assistance from the WG and subsequently joins the local workforce, receiving less than six weeks of unemployment compensation, represents a cost avoidance of ~\$10k each for the AF and increases the local labor pool supporting the military community.



Utilities Privatization Contract for Eglin AFB

- Transmission Tie Line to Interconnect East/West energized March 5th
- Fiber ran and installed in all 10 Eglin substations and 2 switching stations
- Substation Control House set in place at the Main/GWEF substation
- · Over 1,200 Poles replaced so far
- · 115 Manholes Upgraded
- Transformer Equipment Upgraded
 - 10 Ground Mount Transformers
 - 3 Transclosure Transformers
 - 20 Live-front Concrete Pads
 - 43 3-phase Pad Mount Transformers
 - 19 3-Phase Primary Risers
 - <u>3</u> 3-Phase Primary Junction Cabinets
- 13,032' of 3-phase primary cable replaced.
- There have been several additional overhead and underground deficiencies and other NESC code violations corrected.
