RECEIVER AND GUTTILLA MURPHY
ANDERSON, P.C. FOR THE PERIOD
DECEMBER 1, 2019 THROUGH
DECEMBER 31, 2019

Peter S. Davis, as the court appointed Receiver, respectfully petitions the Court as follows:

1. On August 18, 2016, this Court entered its *Order Appointing Receiver*, which appointed Peter S. Davis as Receiver of DenSco Investment Corporation ("Receivership Order").

2. Pursuant to this Court's Order Re: Petition No. 1, the Court approved the Receiver's compensation at the rate of \$250.00 per hour together with all reasonable costs and expenses incurred relating to these services as Receiver. These services are billed by and paid to the Receiver's firm, Simon Consulting, LLC.

1 3. Pursuant to the Order Re: Petition No. 1, the Receiver has engaged the services
2 of the law firm of Guttilla Murphy Anderson, P.C., of Phoenix, Arizona, and the Receiver
3 has agreed to pay the law firm compensation at agreed hourly rates for the services of the
4 firm together with all reasonable costs and expenses incurred on behalf of the Receiver.

6 4. Pursuant to this Court's Order Re: Petition No. 2, the Receiver is authorized to
7 file this fee petition without including as exhibits the itemization of services rendered to, and
8 costs incurred or expended on behalf of, the Receivership, provided that the fee petition
9 includes a statement that anyone desiring additional information concerning the services and
10 costs to be paid under the fee petition may obtain redacted information from the Receiver by
11 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a
12 written request specifying the additional information requested at least three (3) days prior to
13 the date set for any hearing on the fee petition. The Order Re: Petition No. 2 further
14 provides that upon request of the Court, the Receiver shall make available for in camera
15 review by the Court the itemized statements and supporting documentation for the services
16 and costs to be paid under the fee petition.

19 5. The Receiver has submitted an itemized statement for services rendered to this
20 Receivership by the Receiver and his firm, Simon Consulting, LLC, and for reimbursable
21 costs incurred or paid during the period of December 1, 2019 through December 31, 2019.
22 The total amount requested for payment by the Receiver is \$11,542.82. The Receiver
23 believes that this amount is reasonable and should be paid from the Receivership Assets.

WHEREFORE, the Receiver respectfully requests that the Court enter an order authorizing the Receiver to pay from Receivership Assets:

1. The amount of \$11,542.82 to Simon Consulting, LLC, for services rendered and costs incurred or paid during the period of December 1, 2019 through December 31, 2019; and

2. The amount of \$8,529.17 to Guttilla Murphy Anderson, P.C., for services rendered and costs incurred or paid during the period of December 1, 2019 through December 31, 2019.
