- 1. Replacement Upgrades of Controls at WWTP
  - ➤ Holding 10% retainage from Kappe until the software update is completed.
  - Software update was expected to occur around the end of last year.
  - Engineer contacted Kappe on 01/10/2023 to inquire about the completion of the software update, Kappe did not have a time lime for software update.
- 2. Rotary Press Update
  - Scheduled to have a mobile press demonstration at the WWTP Spring 2023 by Tim Tomasko.
  - Project requires a Part II Permit, which can take 6-10 months.
  - Lead time for the press is an additional 8-10 months.
  - ➤ Construction would start in summer of 2024.
  - Engineering agreement for the CMSA Solicitor for review.
  - ➤ Spoke with CMSA Solicitor Barbin on 01/12/2023 approving the agreement.
