- a. North Hampton Park maintenance the board reviewed the trash can replacement bid and the pressure washing of the gazebo. There are 5 trash cans that need to be replaced and a new one added to the right of the tennis courts. The 6 trash cans will cost approximately \$6975.00 and then \$725.00 to pressure wash. Bruce Wilson made a motion to accept the proposal and to have the work done. Kenton Heider seconded the motion, all in favor, motion carried.
- b. Community Events 2023- the board talked about what events would be good for this year. Asked the homeowners present for their input. They would like to try for a spring

event. Management will send out an email to the volunteers and see what they want to set up.

5. LANDSCAPING UPDATES

a. The monuments and pool landscape plantings will be done in the spring. The choice of plants will depend on what is available.

6. NEW BUSINESS

a. Officer Cohen with Pearland Police Department provided will be asked to attend the annual meeting this spring.
