Because of the good job we will receive a rebate of \$282.55. If you are an active customer this will show up as a credit on your next bill. VOMWD did a credit instead of checks to keep the costs down.

CLUBHOUSE REPAIR AND PAINTING SCHEDULE

The pieces are now starting to come together regarding all the planned work we are having done to the clubhouse and pool area. Here's how it looks at this point, which could change, so we urge all of our residents to be flexible in support of these efforts.

19-30 August

Our contractor will be repairing all of the rotten wood, primarily on the exterior but also the interior door leading out of the kitchen area.

Mid-Late September

Our painter has tentatively put us on his schedule for mid-late September to paint the clubhouse interior and exterior which could happen earlier or later. We won't be able to schedule any events in September so we can react to a potential shift in the painting schedule. The pool area pergola, grill fencing, and entrance gate will be included in the painting scope of work. Also, we need time to prep the interior of the clubhouse a few days before the painters begin their work.

Early to Mid-October

The new shutters will be installed right after the painters are done but we currently don't have the exact dates. The new interior shutters will be ordered in late July/early August to allow eight weeks for production, delivery, and installation (we will not be rehanging the old blinds once the interior painting is complete). In summary: the clubhouse work will occur from mid-August to mid-October so we can't schedule any events during this period. Please be aware of any unsafe conditions that may arise in and around the clubhouse due to the various contractor's activities such as slippery surfaces, ladders, scaffolding, trip hazards, tools, equipment etc., not to mention loud noises.

Regular weekly events: As far as these go, we may be able to allow them to continue for the most part but will obviously have to cancel some of them when the time comes that the repair/painting work may preclude meeting in the normal manner. We will work with Linda Jackson to notify these groups in as timely a manner as possible of the exact dates that are problematic and conflict with the work.

We realize that this work will cause some inconvenience for our residents. Our desire is to properly care for the clubhouse by ensuring it is well maintained and enhances the property values here in Chantarelle.

REMINDER TO OBTAIN ARCHITECTURAL CONTROL COMMITTEE APPROVAL

Exterior changes to homes, windows, fences, garage doors, paint colors, gates or roofs must be approved by the Architectural Control Committee (ACC) BEFORE work begins. Request forms are available in the clubhouse, online at Chantarelle.org, from ACC committee members and from Strong Management. Completed forms must be submitted to the ACC at least 30 days before the start of the project to allow time for review and follow-up. When projects involve common area fences shared by both the homeowner and the HOA, additional procedures mentioned in the March 2012 "Report on Common Area Fences" must be followed, including obtaining multiple bids. An additional item has been added to the ACC approval process regarding the display of flags. The American Stars and Stripes, individual state flags, and seasonal/holiday flags may in

most cases be flown without permission. Permission to fly other flags must be requested from the ACC. Adhering to ACC rules will ensure the continued coherence and beauty of the Chantarelle community, while at the same time maintaining the quality of life and desirability of residing here.

SAFETY & WELFARE Emergency Preparedness:

You recently received a brochure from PG&E regarding preparing for wildfire season. If you haven't already done so, I encourage you to read their suggestions and information. Planning ahead is always a great idea!

Scams:

Unfortunately, scams targeting seniors continue, so perhaps it's time to review some old chestnuts. Quite recently, our neighbor received the "Grandma" scam call, where the caller impersonates a grandchild and claims to need money to get out of trouble. Just a reminder to be aware of this type of deception. If in doubt, hang up and contact your family.

And again, be reminded that Social Security and the IRS will contact you **via mail** if it becomes necessary. They will not call, so do not give any personal information over the phone.

I've also received what looked like authentic emails from Amazon and credit card companies.

These scam emails ask you to update password, etc. Don't do it. Mark the email as "junk" and contact your credit card company using the phone number on your card, or log in to Amazon if you have a question about your account.
