According to the New York Times Republicans across the country are looking to stifle protests with several new laws introduced in 16 states legislation. North Carolina legislators want to make it illegal to "threaten, intimidate or retaliate" against state officials. In Iowa City protesters blocked Interstate 80. Blocking roadways could be a felony punishable by 5 years in prison or a \$7,500 fine. They consider this act to be "economic terrorism." In Nashville a motorist stuck a safety worker escorting a protester. A Tennessee state representative introduced a bill that would remove motorist liability should they accidently hit someone blocking a street. Bill to Aid Immigrant Detainees

H.R. 913: Immigrant **Detainee Legal Rights** Act

The Attorney General shall establish and maintain, within the **Executive Office for** Immigration Review, an Office of Legal Access Programs to develop and administer a system of legal orientation programs to make immigration proceedings more efficient and cost-effective by educating aliens regarding administrative procedures and legal rights under United States immigration law and to establish other programs to assist in providing aliens access to legal information.

. The Attorney General shall submit a plan to Congress not later than 180 days after the enactment of this Act including a schedule to develop and deploy legal orientation programs for all detainees not later than 1 year after the enactment of this Act. The Attorney General shall seek input from nongovernmental organizations and stakeholders in developing this plan.

Status: Referred to Committee on Feb 7, 2017. This bill was assigned to a congressional committee on to the White House. February 7, 2017, which will sending it on to the House or Regulatory Reform Task Senate as a whole.
