Installed components are separately warranted by their manufacturer. Collision repairs have a lifetime warranty against defects in workmanship. We warranty the finish of painted surfaces against cracking and peeling for 3 years with the exception of impact or excessive heat. Compensation for downtime or replacement vehicle will be at the sole discretion of Industrial Van & Truck Interiors, Inc. All warranty claims must be made in writing, dated, and presented to Industrial Van at 410-1 Princland Court, Corona, CA 92879.

All electrical installations completed are equal to or exceed industry standards.

Aftermarket equipment and installation may still void portions of your vehicle manufacturer's warranty. Industrial Van & Truck Interiors, Inc.'s liability is hereby limited to the cost of the goods and services provided.

Installing cabinets, shelving, tie-down systems, lifting equipment, racks, tool boxes, tools, flooring, insulation, wall coverings, lighting, window security screens, running boards, parts-inventory, utility bodies, or pipe and vise racks/mounts, may reduce your vehicle's ability to protect its occupants as originally designed and may adversely affect the handling and breaking characteristics and lead to longer stopping distance as well.

Advise us of any difference, and in the spirit of good business and smart negotiating we will guaranty to resolve the difference to the satisfaction of all parties involved to the best of our ability. This estimate is based on visible damage and repairs, any hidden damage found during the course of repair will be assessed for your consideration and approval. We will E-mail, fax, or mail copies of hidden damage for your inspection upon request.

The insurance company, or the responsible party, may request some items diagnosed and estimated as damaged, removed from the estimate. If during the course of repair, are found in fact to be damaged as originally estimated, will be re-included and installed as a special entry intentionally to exclude overlap labor not now applicable. Any additional cost for re-alignment will also be charged.
