SPV Fire/First Responders-BuEComm has been having issues with IVRD and SPV with the first responders paging. IVRD has been using the BuEComm 911Fire paging frequency to page out SPV first responders, but they are bumping us off the tower, they are also paging for things that are not on the criteria list. We have never allowed any agency to use criteria it has been all or nothing and they make the decision to go. The board agreed we need to let them know its all or nothing and Director will advise IVRD to use SPV Fire frequency only and not BuEComm's 911 Fire, so we are not getting bumped off.
