- c. Violations- the board reviewed the violations. The board will work with Montage and the City of Pearland to cure violations.

a. Flock Cameras- The project was delayed due to the City of Pearland permitting process. However, if the camera poles were attached to the monuments, which the association owns there would be no permit needed and if cameras were to be placed at North Hampton and Southdown Drive intersection it would remove the need for a permit for that entrance as well. b. JQ Brick proposal for the fixture of monuments was discussed, Kenton Heider made a motion to approved in the amount of \$5680.00, Kenneth Martin second the motion, all in favor, motion carried.

a. Tree trimming – management has requested proposals from the landscaper to have all the community trees trimmed- in progress.
