**ARTICLES OF INCORPORATION
WEST BRANDYWINE TOWNSHIP MUNICIPAL AUTHORITY**

TO THE SECRETARY OF THE COMMONWEALTH OF PENNSYLVANIA:

In compliance with the "Municipality Authorities Act of 1945" (the Act of May 2, 1945, P.L. 382, as amended and supplemented), the Township of West Brandywine, Chester County, Pennsylvania, pursuant to an ordinance duly enacted by the Board of Supervisors of said Township authorizing and directing the formation of an Authority under said Act DOES HEREBY CERTIFY:

- (A) The name of the Authority shall be "WEST BRANDYWINE TOWNSHIP MUNICIPAL AUTHORITY".
- (B) The said Authority is formed under the "Municipality Authorities Act of 1945".
- (C) No other Authority has been organized under the "Municipality Authorities Act of 1945" or under the Act approved June 28, 1935, P.L. 463, or is in existence in and for said Township of West Brandywine.
- (D) The name of the incorporating municipality is the Township of West Brandywine, Chester County, Pennsylvania, and the names and addresses of the members of the Board of Supervisors of said Township are as follows:
