On June 7, at 8:20am, Officer Ryan Noon conducted a motor vehicle stop on a large moving truck that was travelling on Monroe Avenue in violation of the roadway weight limit. During the course of the stop, Officer Noon determined that a passenger in the vehicle had an outstanding warrant for \$10,000.00 from Bexar County Sheriff's Department in Texas. Officer Noon arrested Tyrone N Williams, Newark, age 51. Mr. Williams was charged with hindering prosecution by providing false information to law enforcement and failure to wear a seatbelt. He was transported to Bergen County Jail to await extradition to Texas.

On June 7, at 6:57pm, Sergeant Kevin Kasak was dispatched to the Wine and Spirit World parking lot for a report of a possible intoxicated person entering a vehicle. Upon his arrival, he located the vehicle in question. The subsequent investigation led to the arrest of Jan Edelman, Wyckoff, age 54. Ms. Edelman was charged with driving while intoxicated, refusal to submit breath samples and possession in a vehicle of an open alcoholic beverage. Ms. Edelman is scheduled to appear in court. Lieutenant Charles VanDyk assisted.

On June 13, at 1:44am, Officer William Plisich was patrolling State Highway Route 208 North, when he observed a vehicle pass him at a high rate of speed and then continue driving erratically. Officer Plisich activated his emergency lights in an attempt to stop the vehicle. The driver continued for some time without yielding, but eventually came to a stop in Franklin Lakes. The subsequent investigation led to the arrest of Angel V Garrido-Sanchez, West Milford, age 45. Mr. Garrido-Sanchez was charged with driving while intoxicated, exceeding the speed limit, driving without a license and disregard of marked lanes. He is scheduled to appear in court. Sergeant Daniel Kellogg and Officer Michael Scalise assisted.

On June 14, at 7:08pm, Officer Kaitlyn Maglione was dispatched to a motor vehicle crash on Russell Avenue. During the course of investigation, Officer Maglione detected the strong odor of raw marijuana inside one of the vehicles. This ultimately led to the arrest of Katery R Andres, Lincolnton, NC, age 21. Ms. Andres was charged with possession of marijuana and drug possession by a motor vehicle operator. Ms. Andres is scheduled to appear in court. Sergeant Michael DeMaio assisted.

On June 15, at 6:04pm, Officer Ryan Noon was patrolling the area of Wyckoff Avenue and Franklin Avenue when he observed a vehicle commit a traffic violation. Officer Noon stopped the vehicle and the subsequent investigation led to the arrest of Nicholas R Oblake, Oakland, age 19. Mr. Oblake was charged with possession of marijuana, drug possession by a motor vehicle operator, failure to possess an insurance card and driving on private property to avoid a traffic signal. Mr. Oblake is scheduled to appear in court. Detective Sergeant Michael Ragucci and Officer Terrence Murphy assisted.
