

Deed Restriction Spotlight - LAWN MAINTENANCE

With spring showers headed our way, this is a great time to get on a lawn maintenance schedule to avoid a lawn gone out-of-control. Make sure to do your part in keeping our neighborhood beautiful.

As part of normal Spring procedure, the management company has begun mailing Certified Demand Letters to any homeowners with lawns which continually remain unmaintained. A Certified Demand letter allows for the Association and its landscaper to enter upon homeowner property, perform any maintenance required and bill all associated costs back to the homeowner.

Here are a few reminders on lawn maintenance:

- Lawn should be mowed and edged
- Expansion joints in the driveway and flower beds should be free of grass and weeds
- Weed control and fertilize lawn
- Take advantage of Spring to trim your trees and bushes



REMINDER: <u>Any</u> improvement to the exterior of your home is required to be approved by the Architectural Control Committee. You <u>must</u> submit a Home Improvement Request form to MASC Austin Properties, Inc. before beginning any work including exterior paint, room addition or driveway, roof or fence replacement. Please make sure submit the form with the required specifications and samples for a quicker response.

Constant Parking Issues At Glenholly Park Drive

Glenholly Park Drive has very narrow streets. We have noticed that vehicles tend to park along the curbs on Glenholly Park Drive, especially in front of the community park instead of their driveways.



A couple of years ago, one of our residents lost their home to a fire. As you can see in the picture, the fire department had a hard time maneuvering though Glenholly Park due to the number of vehicles parked on the street. Several of the homeowners were asked to move their vehicles into the driveway during this disaster. We can avoid causing delays and inconveniences to emergency vehicles and help when disasters like these happen.

This is just a reminder to all our homeowners to make sure to park inside your garage and on your driveway. Use the street parking only if necessary, for example if you have guests or if you absolutely have no room in your driveway to park. Just remember to be considerate of your neighbors.

Vehicles are not allowed to park in front of the entrance esplanade or in front of Glenholly Park. If you see a vehicle parked in these areas, please make sure to report it to MASC Austin Properties, Inc. (713) 776-1771 or you can email pictures to jfigueroa@mascapi.com. Make sure to include date and time of when the vehicle was parked on the esplanade. A warning will be issued to the owner of the vehicle. Thank you for your cooperation in this matter.
