Please check all your trial information carefully on the confirmation you were sent and notify me immediately in writing with any corrections. You can contact me via email at <u>LKSAGE@aol.com</u> or by phone (503) 840-4303 (cell).

SITE INFO: This trial will be held in two rings indoors on packed dirt. There will be crating on the elevated spectator area around the competition. Crating space is somewhat limited, so we ask that you please conserve on space so that everyone who needs crating will be able to find a spot. Please bring chairs, crates, water and clean up tools for your dogs. You may set up your crating space Friday afternoon beginning at 4 pm. NOTE: If you set up before we have the secretary tables, etc set up, your stuff may get moved.

Please DO NOT crate along the railings or ring side. There is also covered crating outside along the building.

DIRECTIONS TO THE TRIAL SITE:

From the North, on I-5: Take EXIT 234A toward Fair/Expo/Knox Butte. Turn slight right onto Airport Road SE. Turn right onto Pacific Blvd. SE/OR-99E. Stay straight to go onto Knox Butte Road E. End at 3700 Knox Butte Road E on the right.

From the South, on I-5: Take EXIT 234 toward Fair/Expo/Knox Butte. Turn right onto Knox Butte Road E. End at 3700 Knox Butte Road E on the right.

MEASURING: All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. Handlers whose dogs need to be measured will not be able to get their armbands until they are measured. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

GENERAL: ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

VOLUNTEERS: Theresa Brown will be our volunteer coordinator. You'll be able to easily spot her as she'll be wearing a high visibility yellow vest. On Sat and Sun, Lunch will be provided to volunteers that work at least 2 classes. For Monday, workers that can work at least 2 classes will get lunch and will be entered into a worker's raffle that is organized by Marjorie Welch.

CONFLICTS: We will do our best to accommodate conflicts. If you have a conflict, Standard takes precedence over FAST and JWW. Put a "C" instead of a check mark on both gate sheets so the scribe and gate stewards will know you have a conflict.

MOVE-UPS: The deadline for move-ups is Monday, Oct 3, 2016 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.
