Beginner Rider- rider any age. Never shown over 2'3; no oxers. Hunters Sponsored by Seventh Farm. Equitation Sponsored by Golden Gate Equestrian.

Twin Cities- Open to pros/non-pros.No oxers.Sponsored by Turn Crest Stable.

Minnesota- Open to pros and non-pros. Oxers included. No championship.

Modified-Open to pros/non-pros, oxers allowed.Sponsored by Arbor Hill Farm

Pre-Child/Adult- any age non-pro rider not having shown over 2'9" in past 2 yrs. Oxers allowed. Hunter Sponsored by Shadow Creek Stables. Equitation sponsored by Stillwater Equine Vet Clinic.

Open- w/oxers. Open to all riders. Horse can only enter Sect A **or** B.
