Delta RDs Bear Burden of Proof to Receive Non-Project Levee Funding From State At their July meeting the Delta Stewardship Council (DSC/Council) adopted a set of Principles and

implementation considerations to provide guidance to consultants for the development of a Delta Levee Investment Strategy (DLIS). Many of the Principles state the Council's pre-determined policies and

require explanation of how levee projects will meet those programs' particular guidelines.

priorities before the methodology for analyzing is completed, so tend to be pre-decisional rather than guidance, including Principle #10 below. The Council held over Principle #10 and directed staff to revise and clarify confusing terminology regarding how many people and/or assets a non-project levee investment would need to protect in order to receive state funding. For Council's approval at the August meeting staff is recommending the following

revised language for Principle #10: "Reclamation districts seeking State funds for non-project levees have the burden to prove their contribution to the protection of people and/or property and the achievement of the coequal goals." The staff report states that this Principle will be "useful guidance for updating guidelines for programs that provide State funds for Delta levees." Staff's justification for adding this as a new requirement for receiving funding through the Delta Subventions Program for maintenance or rehabilitation of non-project levees is that DWR's Urban Flood Risk Reduction and Delta Levees Special Projects programs currently

The Delta Subventions Program is a Central Valley Flood Protection Board (CVFPB) program, but the board has not submitted any official board comments on DLIS or on this particular Principle. However, the CVFPB has conducted one public workshop and Chairman Bill Edgar and board member Clyde Macdonald did provide testimony of their personal views at the June meeting which is available here, which unfortunately do not necessarily align with the views of the Association and Delta RDs. Next steps include workshops for stakeholders to demonstrate the DLIS tool and its metrics, with the intent

to finalize a draft strategy and EIR by December 2015.

DSC Scrutinizes San Joaquin County's Proposed Urban Levee Improvements and Development The Delta Stewardship Council's (DSC/Council) meeting on August 27-28 will include a discussion of elements in three different land use and levee projects proposed in San Joaquin County that DSC staff believe are inconsistent with Delta Plan Policy DP P1. Agenda item #13 highlights DSC staff concerns regarding:

Lower San Joaquin River Feasibility Report/DEIR/DEIS - SJAFCA flood protection project elements that induce urban development of agricultural lands. Urban Flood Risk Reduction Program Funding Recommendations - DWR funding guidelines

This agenda item is intended to update the Council on the staff's written comments and conversations with

San Joaquin Co. 2035 General Plan Update – conversion of agricultural land in six areas to

San Joaquin county flood control agencies on these projects and have the Council support the staff positions pursued so far and provide direction regarding their continued effort to seek revisions to these

projects. If the Council ultimately finds that any of these projects, as "covered actions," are inconsistent with policies in the DSC Delta Plan, then the project may not proceed until it is revised to be consistent. The County, RD 17, and SJAFCA are working with DSC staff to ensure their projects are in fact consistent

with the Delta Plan.

Climate Change Planning Anticipates More Frequent Drought and Floods Concerned with climate change stressing strained water resources even further, DWR's Climate Change Technical Advisory Group recently released their preliminary findings in a report: Perspectives and <u>Guidance for Climate Change Analysis</u>. Global climate model selections appropriate for California water resources, planning for extreme conditions, and recommendations for future work are discussed. CalEPA also released Climate Change Research Plan for California report focusing on filling research gaps to help the state identify necessary mitigation and preparedness measures we should start taking now. In an effort to educate teachers about basic climate science, DWR is partnering with Project WET (Water Education for Teachers) to host two workshops next month: September 12th in Redding and September 19th in Fresno.
