PUBLIC PARTICIPATION:

to be torn down. Trustee Ellinger advised there has not been any updates on the home being

wanted to know what the next steps would be. Trustee Wolfe stated he would meet with them to

attempt and locate these two plots at the Hamburg Cemetery.

ZONING:

CORRESPONDENCE FROM THE FISCAL OFFICER:

Minutes from the January Meeting being read prior by the Board were approved as read, so moved by Trustee Wolfe and seconded by Trustee Hurley. All were in favor with 3 ayes and no negative votes, motion passed. Fiscal Officer Ressley asked for resolution to move from temporary appropriations to permanent appropriations for FY24. Trustee Wolfe motioned to move from temporary appropriations to permanent appropriations for FY24. Trustee Hurley seconded. Roll call vote Ellinger – Yes, Hurley – Yes, Wolfe -Yes. Motion approved.

FIRE DEPARTMENT:

Fire Chief Golden reported monthly runs so far have been 31 fire and 40 EMS for a total of 173 runs YTD. Mutual aid was provided to Amanda, Berne, and Greenfield. March – May is the burn ban from 6:00am – 6:00pm.

OLD BUSINESS

- Scott Brown's property is making progress. We received the signed copies where the
 certified letters were sent. We have sent a mailed copy of the certified letter to Scott
 Brown on the advice from the Fairfield County Prosecutors Office. This went out to bid
 in the newspaper and scaled bids will be opened during the March board meeting.
- 2. Windy Hills Road property nuisance issue is now back under the control of Roger Ruble. He will be backfilling the holes and addressing the property.
- 3. Shelly will come back in the spring to place the AC bands on the driveways on Meister Road. Pictures and addresses were taken.

- 5. Trustee Wolfe motioned to not adopt the resolution regarding the passage of issue II.

 Trustee Hurley seconded the motion. Roll call vote Ellinger Yes, Hurley Yes, Wolfe Yes. Motion approved.

NEW BUSINESS:

- The trustees received an email from Rushcreek To9wnship about solar farms and a
 resolution they passed asking the county commissioners to pass a resolution prohibiting
 construction of economically significant wind farms, large solar facilities, and large wind
 farms. They had asked Hocking Township to review and respond with our decision.
- Mid Ohio Tree quoted \$2400.00 day to trim and clean up trees on Snoke Road. Trustee
 Wolfe motioned to accept the quote and not to exceed 2 days in their work schedules.
 Trustee Hurley seconded the motion. Roll call vote Ellinger Yes, Hurley Yes, Wolfe Yes. Motion approved.

Trustee Hurley moved to pay the warrants for the month seconded by Trustee Wolfe. Roll call vote Ellinger – Yes, Hurley – Yes, Wolfe -Yes. Motion approved.

There being no further business to discuss Trustee Ellinger motioned to adjourn and Trustee Wolfe seconded the motion.
