The regular meeting of the Board of Directors of Arrowbear Park County Water District was held January 21, 2016 at the Water District office, 2365 Fir Drive, Arrowbear Lake, California.

Open Session

President Bunyea called the meeting to order. Director Rick Weber led the recitation of the Pledge of Allegiance. President Bunyea certified the posting of the agenda. President Bunyea performed a roll call, all 5 Directors were present.

Approval of Consent Agenda:

Director Weber made a motion to accept the consent agenda. Second was by Vice President Wymer. After a brief discussion regarding the Expenses & Budget for the month of December, the Consent Agenda was approved. Motion passed by unanimous vote.

Public Comments:

There were no public comments.

Staff Reports:

- A) Supervisor Miller reported a total of (38) maintenance issues for the month of December. There were (12) shut off/turn on for non-pay/payment received, (2) Customer request to turn off/on water, (11) Turn on/off for plumbing repairs, (2) New owners, (4) Customer service issues, (2) Meter re-reads, (0) Lien filed/released, (1) Meter replacements, (2) Main Repair, and (2) Service line repairs. Supervisor Miller introduced the District's newest employee, Utility Worker, Bryant Jackson. Bryant gave a brief biography of himself & answered questions from the Board.
- B) Chief Hall reported on the Summary of Calls for December. There were a total of (17) calls, (13) were in the District and (4) were out of the District. Chief Hall announced a new volunteer, Nathan Dobbs, would be starting at the Fire Department. Chief Hall updated the Board on Captain Ozias' upcoming trip to Pennsylvania for the pre-

construction meeting for the new fire engine, scheduled to be ready in November 2016. Chief Hall remarked that the Fire Fighter's Association was beginning the process of planning for the annual 4th of July picnic for 2016. Chief Hall also commented that the Volunteer Fire Fighters are continuing their Fire Fighter I Certification.

C) General Manager Huff reported that the winter projects are in process including the rock sifter to separate asphalt. General Manager Huff is preparing a presentation on the District's position regarding Running Springs Water District proposed charges (based on EDU's rather than actual flow) for the Wastewater Treatment Plant for the Board of Directors to be presented at the February 21, 2016 Board of Directors meeting. General Manager Huff closed his comments with the State Water Resources Control Board's recommendation that mandatory water conservation remain in effect until October, 2016, they will vote on extending the regulation Feb. 2, 2016.

President Wymer excused any individuals who were not required for the balance of the meeting and the Board took a 5 minute break.

DISCUSSION / ACTION ITEMS:

A) Board

- 1. The Annual election of Board Officers was conducted for Arrowbear Park County Water District
 - a) Director Bunyea asked for nominations for the 2016 Board President. Director Bunyea nominated Director Wymer. Second was by Director Weber. Director Weber nominated Director Bonito, there was no second. A vote was held: (5) for Director Wymer. Director Wymer will be the Board President for the year 2016.
 - b) Director Bunyea then asked for nominations for the 2016 Board Vice President. Director Oberlies nominated Director Weber. The nomination was declined by Director Weber who then nominated Director Bunyea. Second was by Director Bonito. A vote was held: (5) for Director Bunyea. Director Bunyea will be the Board Vice President for the year 2016.

The gavel was passed to the new President Wymer and she thanked former President Bunyea for his work for 2015.

- 2. President Wymer asked for a motion to approve Caroline Rimmer as Board Secretary. Director Weber made the motion. Second was by President Wymer. Motion passed by unanimous vote.
- 3. A motion was made to re-appoint Norman Huff, General Manager, Caroline Rimmer, Board Secretary, Rick Weber, Director & Terisa Bonito, Director, as signers on the District bank account. Motion made by Director Weber. Second by Director Bonito.
- 4. A motion was made to affirm the regular Board meeting time and day for the 3rd Thursday of each month at 6:30 PM. Motion made by Director Bonito. Second by Director Oberlies. Motion passed by unanimous vote.
- 5. Financing Corporation
 - a) At 7:56 PM, President Wymer adjourned the regular meeting and opened the annual Finance Corporation meeting (See Minutes for Finance Corporation). Director Bonito made a motion to appoint the newly sustained officers of the

Board to be in the same positions for the Finance Corporation Board officers for the year 2016. Second was by Director Weber. Motion passed by unanimous vote.

- b) President Wymer adjourned the Finance Corporation meeting.
- c) Reopened the regular Board meeting at 7:58 PM.

- B) Board Members: Vice President Bunyea thanked the Board for allowing him to be President for 2015.
