## September Program Toni King, Medicare Expert, Author, Columnist, Speaker



The following is a recent example of her column. Don't miss this program if you are remotely interested in Medicare!

Last year, my mother got into the "donut hole" in October. I can see from the Part

D statement she receives that she is rapidly approaching the donut hole and it is only the beginning of May. None of her drugs have changed from 2016.

She can afford her co-pays of \$180 per month that she pays at the pharmacy. The monthly Part D statement says the prescription drugs' cost is \$950 per month. I'm confused.

Please give me some ideas to help control this cost! Thanks, Jennifer from Dallas, TXJennifer

Your mother's prescription drug problem is a typical problem since the cost of brand name prescriptions has risen dramatically. She can afford her \$180 co-pays, BUT... has no idea that the true cost of her prescription drugs is \$950 each month.

Once her Medicare Part D prescription drug plan and the co-pays she pays total **\$3700** for 2017 for her **covered** drugs, then she is in the famous "Donut Hole" or coverage gap.

She must pay the next **\$4950** to get out of the "Donut hole". She will pay 40% for a brand name drug and the brand name drug

manufacturer will pay 50% of that covered brand name drug. Now the remaining 10% will be paid by the prescription drug plan which she enrolled in.

What happens if your brand name drug is not a "**covered**" brand name drug on your specific Part D plan? You will have to pay 100% of that brand name drug.

Generics cost less, and for 2017, the cost is a 51% co-pay when in the "Donut hole". Many brand name drugs do not have a generic alternative to use.

That is why it is important when choosing a Medicare Part D prescription drug plan, whether beginning Medicare for the first time or during Fall's Medicare's annual enrollment, to be sure all prescriptions are covered on one's Part D plan.

Do research prior to enrolling in a Part D plan because if you choose the wrong plan, you cannot change it until Medicare's annual enrollment period, which is from October 15<sup>th</sup> to December 7<sup>th</sup> every year.

January 1 of each year, the process starts all over again with a new Medicare Prescription Drug plan and different costs, deductibles, and a new Donut hole.

Toni's Tips to help you stay out of the Donut Hole or not get in it as soon!

- Visit <u>medicare.gov</u> when selecting a Medicare Part D plan, whether it is your first time or changing during Medicare's Annual Enrollment Period in the fall. *This is an accurate* way to view the cost of drugs and which plan and pharmacy are most cost effective.
- Talk to your doctor or doctors about which brand name drugs can be changed to generics.
- Get samples from your doctor.
- See what generics are in a \$4 or \$5 generic prescription drug program at HEB, Wal-Mart, and Costco etc.... Pay for the generics **out of your pocket**. To get their discounted price, you only need a prescription from your doctor.
- Contact the Prescription Assistance Program in Lake Jackson at 979/285-1430, which has saved over \$64 million dollars helping people get their prescriptions at affordable prices when they can't pay for them.





The Scholarship Program of the Metropolitan Houston Chapter was organized late in the year 2000 and a scholarship was first awarded in June 2001, making this the 17<sup>th</sup> consecutive year that your chapter has given a college scholarship. Your chapter was the first in the Chevron Retirees Association to award such a scholarship. This scholarship is funded totally by your voluntary donations.

The Scholarship Committee factors in numerous selection criteria such as grades, test scores, class rank, confidential references, plus an essay, all of which must be submitted by the deadline.

The final selection of this year's scholarship recipient went to Michaela Christine

Reinhart. Michaela's grandparents, Ray and Rita Casserly, accepted on her behalf the \$2,000 scholarship check, a framed certificate stating that Michaela was awarded the scholarship, and a wooden nameplate made and donated by your fellow member Ricky Mercado. Michaela will be attending Duke University in the fall as a member of the Class of 2021.

Online Directory

Did you know about the powerful tool that you have access to find fellow retirees within MHC? Just browse on your computer, tablet, or smartphone to MHC's website: <u>www.cra-</u> <u>metrohouston.org</u>. Now find the Directory menu tab, and if you point to it you'll see a drop down menu item How To Create Your Logon. Click on it and you'll have all the instructions to get you started. After you register, you'll receive an email confirming your registration. If you do not receive this message within an hour, please send a note to <u>membership@cra-metrohouston.org</u> so we can approve your logon manually.

After the logon information, there are instructions on how to use the directory search. This online directory search contains the most current information from our database. It is updated at least quarterly but often sooner. Let's say you meet someone at a luncheon, and you remember his name is Bob or Bill or at least something that starts with "B". You can search the first name with the first character, or the last name with the first character. Of course, the name field searches can be narrowed down by entering more than one character to search for, "Bo" for example will find Bob but not Bill. What if you think you would like to go to a luncheon but you aren't sure you can drive that day? You can search the directory by your 5-digit zip code and find all the MHC members who live in your area. Be sure to leave the name fields blank for this to work.

MHC supports the Houston Food Bank with our donations of non-perishable food and paper goods and cash. Because the Food Bank purchases in very large quantities and with significant discounts, we are advised that your \$1 contribution to them provides a full day of meals to a needy neighbor. Therefore, if you are going to purchase items for this purpose, consider donating the money; it purchases a lot more when HFB spends it for you, and it will be used to purchase items HFB needs most. To facilitate monetary donations, we will place a donation jar for the HFB on the registration table.

When you donate \$20 or more at one time, you can double your impact by filing with Chevron HumanKind for matching funds. Their rules require you to validate your donation with either a cancelled check or a receipt. Since our MHC Chapter does not provide receipts (since we are not the Food Bank), we recommend you donate with your check made payable to Houston Food Bank.
