Expired permits Permits that have expired after six (6) months will be re-issued at one half (1/2) the original permit fee if the amount is less than \$100.00. If the permit fee is greater than \$100.00, a fee of \$50.00 or 10% of the original permit fee whichever is greater shall be paid prior to continuing any work. A cancelled permit can not be reinstated.
