### Studio Policies & Parent Information:

***Please read CAREFULLY and initial that you understand and agree to the following:***

- \_\_\_\_\_ Full tuition is due the first class of each month. (half tuition for August) We do not bill.  
**A \$15 late fee will be added to tuition on payments received after the 7<sup>th</sup> of the month.**  
\$25 fee on all returned checks. ***Students are registering for the full school term (Aug– June), not for individual classes.***  
The number of classes may vary per month. The term is divided into 11 equal full tuition payments Sept/June (half tuition August)
- \_\_\_\_\_ Half monthly Rate plus the yearly registration fee are due for August registration. ***Classes start Monday August 21, 2017.***
- \_\_\_\_\_ Classes are not pro-rated for missed classes. A missed class must be made up within the month missed.
- \_\_\_\_\_ Tuition and fees are non-refundable. Non-transferable.
- \_\_\_\_\_ Full tuition is due for the months of ***December and June.*** NO tuition is deducted for snow days or holiday closures.
- \_\_\_\_\_ Students are required to have proper shoes and dance attire for each class. (See office for specific information on attire)
- \_\_\_\_\_ **If a student wishes to discontinue classes, 30 day written notice must be given to the studio office.**  
If proper notice is not received a withdrawal fee of one month's tuition is required.
- \_\_\_\_\_ In addition to monthly tuition, there are fees for registration, each recital held and costumes.
- \_\_\_\_\_ All fees must be paid in full before the due dates in order for dancers to participate in any studio events.
- \_\_\_\_\_ **All team students are responsible for attending and paying all fees associated with competition & convention, specialized choreography, master classes, WINTERFEST and SUMMERFEST and they enrolled through the entire season.**
- \_\_\_\_\_ **A \$200 non-refundable deposit for Summerfest will be due at the first team meeting for all team members.**

### Participant Waiver:
