**Terms of Agreement:**

**Payment:**

- Payment is due upon completion of service in the form of cash or check.
- There will be a \$25 charge for returned checks.

**Cancellations:**

- Cancellation Policy: There will be no charge for cancellations 2-weeks out from event date. If the event is cancelled without a two week notice, we require a \$25 cancellation fee.
- Should it be necessary to cancel a booking, re-booking may be subject to date/time availability and peak season rate changes.

**Travel:**

- A travel fee may be charged for bookings beyond a 20 mile radius of Parma Heights, OH. If total drive time exceeds 1 hour, the artist may require a 2-hour booking minimum. Travel fees are not included with coupon discounts offered.

**Age:**

- Face painting is not recommended for children under two years old because their skin is so sensitive and susceptible to irritation from cosmetics. The artist is not responsible for reactions should a parent insist that their child be painted.

**Safety First:**

- For sanitary reasons, I reserve the right not to paint anyone with a bad cold, runny nose, cuts or open sores on the face. In this case, I will paint another area of the body. Brushes and sponges are cleaned and sanitized before each event. I used FDA approved paints and cosmetic grade glitters that wash off with soap and water.

**Breaks:**

- After working two hours, a ten minute break will be taken. If the booking is for four hours or more, a ten minute break will be taken every two hours. The artist will require access to lavatory facilities and water, and will need to be permitted to use them when needed. It is expected that all of the artist's supplies will be kept secure during bathroom/water breaks. At no time will any guest be permitted access to the artist's supplies/equipment without her expressed permission, even in her absence.

**Stop Time:**

- The artist is only obligated to paint for the duration indicated on the contract. The client may request that the artist continue to paint beyond the duration of this contract, however the artist reserves the right to decline an extension without penalty. Extensions are billed at \$50/half hour to be paid at the time of the request.

**Working Conditions:**

- The client is liable for damages for and the artist reserves the right to discontinue services if faced with a situation that poses a threat to his/her person, supplies and/or property and the client fails to properly remedy it to the artist's satisfaction. Adverse conditions include, but are not limited to: extreme weather, a hostile environment, violence, illegal activity in or around the vicinity of the painting, and destructive and/or abusive behavior on the part of any person or pet attending.

**Artwork:**

- The artist reserves the right to not paint subject matter than is offensive, objectionable and/or disturbing. When in a public venue, the artist will only paint portions of the body that can be lawfully exposed in public. In private, the artist reserves the right to not paint any areas of the body she doesn't feel comfortable painting.

**Photography:**

- Photography: The artist may desire to take photographs of the artwork she produces for portfolio, website and other business usage. In this instance, the artist will bring individual photo release forms for parents to sign. If you would like to grant the artist permission to do this, please initial \_\_\_\_\_. If the client desires a disk copy of the photos taken it must be requested.

**Lines:**

- If there is a line, I will paint numbers on hands and give a wait time so the kids can do other activities and come back when it's their turn to be painted.
- Anyone requesting a touch-up will be required to go the end of the line.
