VILLAGE OF COHOCTON MONTHLY MEETING June 15, 2016

The monthly meeting of the Cohocton Village Board of Trustees was held on Wednesday, June 15, 2016, at 7:00 pm, in the Village Office, 17 South Main Street, Cohocton.

A motion was made by Trustee Sahrle, seconded by Trustee Azzi to enter into executive session at 7:26 pm to discuss personnel issues. The motion carried 4-0.

A motion was made by Trustee Gray, seconded by Trustee Azzi to exit executive session and to enter into regular session at 8:30 pm, with the following action taken:

A motion was made by Trustee Gray, seconded by Mayor Cox, Due to the seriousness of the incident, the Village employee responsible for posting the June 6, 2016 water shut off list to social media will be suspended from work with no pay June 20 through June 23, 2016, with a letter of reprimand from his Supervisor to be placed in his personnel file. The next offense could result in termination. The motion carried 4-0.

Mayor Cox stated that the letter requesting the speed limits to be lowered at the Village lines was sent to the New York State Department of Transportation.

A motion to adjourn was made by Trustee Azzi, seconded by Trustee Sahrle, the meeting was adjourned at 8:30 pm.
